- Insure annual contract review is completed (if applicable) (send update to Presbytery Office)
- Insure EXIT interviews are scheduled and completed
- Communicate Presbytery happenings, training events, for officers, PNCs, Clerks of Session.
- Report to COM timely prepare & submit motion(s) for consideration at COM Meeting.
- Provide Updates for COM's Presbytery Church Worksheet
- Welcome new pastor assist/support mentoring process
