Addendum B Presbytery of Geneva September 17, 2013

Report of the Mercy Place Administrative Commission 09-17-13

Linda Kataskas (RE), Cheryl Peeples (TE), Bryan Bond (TE), Tom Bailey (RE), Bob Bell (RE), David Ashby (TE, convener)

The Administrative Commission continues to oversee Mercy Place as a New Faith Community/NCD, to develop specific strategies for the project, and to review and discover funding options.

Bryan Bond continues to function as the Organizing Evangelist of Mercy Place, meeting with individuals and leading small fellowship and semi-worshiping community events in the VanEtten and Ithaca area. Given the nature of the persons we are approaching, Bryan is keeping the group events informal and low-keyed. Whether participants will be interested in moving toward a more recognizable "worshiping community" as the PC(U.S.A.) envisions them remains to be seen, but Bryan and the AC are committed to nurture Mercy Place for at least another year to give the vision of community enough time to develop.

Overtures to First Presbyterian Church in Ithaca to become a partner in Mercy Place have been delayed by their search for a new pastor.

The AC continues to work on how Mercy Place may fit into the "evolving" General Assembly funding patterns, and is watching very carefully the Synod of the Northeast funding patterns which will be emerging shortly with the Synod Assembly in October 2013. The potentially greater flexibility in Synod and GA funding could be very helpful for this mission which does not fit in traditional categories. In the meantime, the AC is working on our 1001 Worshiping Community application (which is fairly structured, but far less than the New Church Development application) and on the less structured Seed Grant of up to \$7,500. Both will need the endorsement of Presbytery Council for submission.

We anticipate the 2014 Mercy Place expense budget to be the same as 2013, but the income side is, as mentioned above, still a work in progress.

In the meantime, we ask for your support, ideas, and prayers as we nurture a place for souls uncomfortable in traditional congregational settings.

Addendum I Presbytery of Geneva September 17, 2013

Cynthia A. Weaver Statement of Call

The realization that I have a call to ministry came very slowly over time. I was born and raised in the Presbyterian Church (United Presbyterian Church in the U.S.A. and now PC(USA)), and I always took the church and its teachings seriously, though I never considered that the seriousness I felt might be an aspect of call. Several years ago our associate pastor at the time noticed my interest in learning more about the Bible than was afforded in our church's Bible study classes. She suggested I take a class at Colgate Rochester Crozer Divinity School (CRCDS), and while I was hesitant, I knew I wanted to know more, and it was this desire to know more which led me to take another class and then another and eventually to matriculate.

While I knew I loved learning about the Bible and church history and theology, it was others who noted the passion I expressed when talking about my classes and who first mentioned the word "call". I was reluctant to acknowledge the growing excitement I felt as I took more and more classes and began to consider being in the pulpit and preaching. After all, I had a profession I enjoyed and had no practical reason to consider ministry, but the pull to pursue ordination grew stronger. Even though I was expressing my hesitance to others, I was at the same time carefully meeting the requirements to receive a Master of Divinity degree from CRCDS and beginning the discernment process by becoming an Inquirer with the Susquehanna Valley Presbytery.

God has always been very gentle with me, never getting my attention in loud or frightening ways. Instead, God taps me on the shoulder and whispers, "Psst, look over here." What I have found in this process of discernment, when I have dared to look, is one open door after another, and God has been patient with me while I stood at the threshold of each for quite a while before daring to step through. Each time I do my excitement grows, and I find welcome and encouragement and more open doors in the path ahead.

During the 2012-13 school year my placement for Supervised Ministry was at First Presbyterian Church in Elmira. There I was given the opportunity to preach and teach and minister to the congregation, and I found myself feeling the joy of being more fully who God made me to be than I have ever felt in my current work as a psychologist or in any other endeavor. As a result, and only with the help and persistence of the Holy Spirit, I believe I have a call to ordered ministry in the Presbyterian Church (USA) as a teaching elder.
