#### (Approval of Call)

The presbytery heard from members of Christ the King Fellowship regarding the call of Sabrina Slater as Stated Supply. They shared the process by which the call was determined and extended. [NOTE: While the call as Stated Supply is made by the session and the presbytery, the session of Christ the King Fellowship deemed it important to the life of the congregation to have the candidate appear before the congregation, and for the congregation to "advise and consent" regarding the call.]
