### THANKING OUR PAST MODERATOR

Transitional Leader Linda Badger Becker offered appreciation to Elder Joann Braun (Naples, Trinity) for her leadership as Moderator of the Presbytery of Geneva. Linda invited Joann to the chancel, and presented her with a bouquet of long-stemmed yellow roses, because as expressed by her e-mail address, Joann is "Texas Yellow Rose."

### **ADMINISTRATIVE COMMISSIONS**

### (Dundee, First)

Paul Malles, Chair of the Commission, was unable to be present. In his stead, Dick Schied reported that the congregation was dissolved as of December 31, 2017 and the Administrative Commission is now fully responsible. Items in the church are being inventoried, and many of those items will be soon available for the asking/taking. In the near future, there may be an offer for the church building.

#### (Romulus)

Stephen Beals reported that Romulus Presbyterian Church will close, effective April 2, 2018. The Easter Sunday service will be led by Elder Joy Novack, CRE. The remaining \$1,000 in the church account will be presented to Joy, in appreciation for her years of service to the church. The contents of the church are being inventoried, and many items will be available for other churches.

#### The presbytery VOTED to:

Concur with the request of the congregation of Romulus Presbyterian Church to be dissolved effective April 2, 2018.

### (Elmira, Westminster)

Elder Jim Varner, clerk of the Administrative Commission, reported. The Administrative Commission is beginning its work. The stated clerk provided orientation on January 26. The Commission met with the church session in February; the session is fully functioning. The building will soon be listed for sale. Consideration is being given to how the congregation may continue to worship and serve, following sale of the church building.

## (Williamson)

The Rev. Tim Johnson reported for the Administrative Commission. The process of the transfer of the church to the Evangelical Presbyterian Church has been a long one. In 2015, the presbytery voted, "If the way be clear" to transfer the church's membership to the Evangelical Presbyterian Church. All of the conditions set out in 2015 have been met, including payment to the Presbytery of Geneva of \$11,000. All re-incorporation requirements have been met, and the deed and title have been transferred to the church.

There is \$4,488.48 in the Hay Grant, specifically earmarked for coaching.

12. Adrian Tierson reported that a Response Team has been formed and is working with respect to a situation involving alleged sexual misconduct.

### (Small Church Network)

Stephen Beals offered a presentation concerning the First Presbyterian Church of West Fayette, which he serves as Commissioned Ruling Elder. He shared West Fayette's experience hosting a program to address the opioid addiction crisis. Last summer, the church hosted a four-week workshop on opioid addiction. Five city agencies provided leadership, including addition counselors, recovering addicts, and law enforcement. There was no cost to the church other than time, location, and food. Twenty-four persons attended the first session, and most of them returned for the following three sessions. Stephen shared the three "take-aways" from the experience:

- 1. Opioid addiction is a disease.
- 2. The disease can attack any-one. There is now a Nar-Anon group in the county.
- 3. "If we can do it, you can, too."

#### **COMMITTEE ON PREPARATION FOR MINISTRY**

John Gingerich offered the report. The Committee cares for persons seeking ordination to Ministry of Word & Sacrament, and persons seeking to become Commissioned Ruling Elders. He reached out to those who may be feeling a call to those ministries, and encouraged them to be in contact with him.

# Business Related to Mission: "...to be Christ in the Finger Lakes and the world...." CAMP WHITMAN

Linda Badger Becker presented the report on behalf of Lea Kone, Camp Whitman Director. Camp Whitman has been engaged in an intensive Strategic Planning Processs led by Run River Enterprises. Run River specializes in consulting with camps. She briefly outlined the process of Strategic Planning:

- Purpose/Mission
- Vision/Strategy
- Structural Organization
- Staffing

She noted that the General Council is the "Camp Operator." The Advisory Committee (comprised of five members from the Presbytery of Geneva and four members from the Presbytery of Genesee Valley) advises the General Council.

The mission of the camp is focused on:

- Christian Community
- Deepening our connections with the earth
- · Experiencing diversity as a gift from God.

## The emergent vision includes:

- Leadership in the stewardship of God's creation
- Exceptional hospitality as an expression of Christ's love
- Enabling all persons to grow in servant leadership

## Emerging recommendations:

- Program growth
- Marketing
- Organizational Development (the model of subsidy by the presbyteries is not sustainable)

Leah Ntuala and Jane Winters presented the report.

The Committee has put out two newsletters: Black History Month (February) and Women's History Month (March).

Leah read Matthew 5:14-16 and led the chorus, "This little light of mine, I'm gonna let it shine." She asked, "How does this story of the shining light *matter* to my church?"

### PRESBYTERIAN WOMEN

Linda Werts presented the report.

Linda celebrated the Women's Birthday offering, and noted that Park Presbyterian Church, Newark received a grant from the Birthday Offering, to build a church in South Sudan.

Women's Birthday Offering materials will be made available during lunch. Linda encouraged support of the Offering.

On April 6 there will be a farewell dinner in honor of the Rev. Kirk Baker, as his service a Park Presbyterian Church comes to an end.

## **SYNOD MISSION & MINISTRY COMMISSION**

The report is included in the General Council Report.

Betsey Crimmins reported concerning recent mission involvement by First Presbyterian Church, Elmira, NY. The church has been involved in Mission Trips to Puerto Rico. Relationships have been developed, and phone contact continues. The Church engaged in a major fund-raising event for Presbyterian Disaster Assistance: the goal was \$10,000. The church held a major dinner in December, which expanded the church's heart to be involved. Leslie Latham of the PCUSA Puerto Rico Task Force spoke during the dinner.

Betsey noted that Hurricane Maria has had a huge impact on Puerto Rico, and on the people who are involved in ministry to the country. She shared a major take-away for Elmira, which all churches can experience: Encourage your congregation's involvement in mission beyond the church. Whatever you do will bring revitalization and energy to your congregation.

At Betsey Crimmins' request, the Moderator led the presbytery in prayer for the recent school shooting in Maryland.

## **GENERAL ASSEMBLY**

The presbytery considered the request from the session of First Presbyterian Church, Ithaca, that the presbytery concur with General Assembly Overture 2018-006 (Divestment from Fossil Fuel Investmentsd, and Re-investment in Sustainable Energy).

The Rev. Kirianne Riel, Pastor of First, Ithaca noted that it was not the session's intention to present the Additional Rationale for the presbytery's consideration. The session's request is limited to concurrence with the Overture as presented by the Presbytery of Hudson River.

The Moderator presented the question for the presbytery's consideration: Shall the Presbytery of Geneva concur with Overture 2018-006?

Elder Brad McFall, a member of the Justice, Peace, and Integrity Committee of First Presbyterian Church, Ithaca, spoke to the request for concurrence. He noted that 31 presbyteries throughout the PCUSA have concurred with the overture.

The presbytery VOTED to concur with Overture 2018-006. [NOTE: The vote was not unanimous. No one requested that their dissent be registered.]

John Gingerich, Chair of the General Council, presented the report.

## **ITEMS FOR THE PRESBYTERY'S ACTION**

The presbyery VOTED to:

(Vision Statement)\

1. Approve the following Vision Statement for the Presbytery of Geneva::

Radiating the light of Christ, the Presbytery of Geneva thrives as a community of servants, lifting up every congregation and leaders in ministering together.

<u>Background:</u> Following the General Council meeting on March 13, 2018 the General Council continued their Transitional Work, with the goal of producing a Vision Statement which would accompany the previously approved Purpose Statement. The above motion is the fruit of that work.

## ITEMS FOR THE PRESBYTERY'S INFORMATION

The General Council VOTED to:

## (Camp Whitman – from the February 13, 2018 meeting)

A motion was made and seconded that the General Council:

Refer the discussion to the Budget & Finance Committee; and request that the Budget & Finance Committee report
to the General Council in March regarding the source of necessary funds for additional consulting by Run River. [The
motion passed with two "no" votes.]

After much discussion, the General Council VOTED to:

- 2. Authorize a site appraisal of the Camp Whitman property; and
- 3. Request the Budget & Finance Committee to find the money to pay for it.

[The motion passed with one "no" vote.]

#### **Background**

The General Council received the preliminary report of the Run River consultant process, in preparation for further reflection during the Council's March meeting.

Elder Phil Opdyke (Palmyra, Western), a member of the Camp Whitman Advisory Committee, responded to questions from General Council members.

Phil reported that the Advisory Committee participated in three overnight workshops, held at different locations (including other camps). The work was extremely productive.

Camp Whitman cannot continue viably, in the way it has. The facilities have become—frankly—dilapidated. To put the facility into reasonable shape will cost a *lot* of money. As dilapidated as the camp has become, the Run River consultants made clear that they have seen much worse. The property is valuable and the program is good. The camp cannot charge more because the camp is so rustic. Can we continue running the camp in 2019? Or 2020? There are many things to address this season (2018).

- An important next step is to do an appraisal of the property—a full site assessment.
- If we cannot achieve the volunteers for 2018, the future work will be difficult, if not impossible.

- Are we going to enter into a transforming (transfiguring?) Camp Whitman ministry?
- The presenting issue is funding the consultants for additional work, and engaging an appraisal. The
  estimated costs are:
  - o Additional consultation by Run River -- \$8,300.00
  - o Site appraisal -- \$5,000.000 \$7000.00
  - o Total -- \$13,300.00 to \$15,300

It was noted that the appraisal may not be as expensive as indicated above.

How will the General Council communicate with the presbytery regarding Camp Whitman?

- We have to talk beyond the fliers that are sent and distributed.
- We have to be transparent regarding ALL of the concerns.
- The Moderator's letter may be one resource.
- An attractive one-page printed resource, with a clear outline of the concerns and possibilities for transformation.

### (Presbytery Prayer Directory)

4. **Authorize** Katherine Griffis and the Communication Committee to proceed with developing a *Presbytery Prayer Directory*, the first edition of which will be presented to the March meeting of the presbytery.

## **Background**

Katherin Griffis reported to the General Council that the following persons are serving on the Council's Communication Committee: Stephen Beals, Leah, Ntuala, and Ellen Reynods. (The Transitional Leader will provide staff support.)

Katherine and the Communication Committee are working to develop a Prayer Directory for the presbytery. Every month would feature five congregations (with a picture and a brief summary of the church's current mission), with the encouragement that members of the presbytery pray for the churches represented on the monthly page. This would be very similar to the *Mission Yearbook for Prayer*.

#### (Attorney / counsel for the presbytery)

- 5. Authorize securing legal counsel for the presbytery, with a retainer to be negotiated.
- 6. **Authorize** the Council Chair to appoint a Task Force to work on the logistics, including a recommendation for funding. The Task Force will include Tim Johnson, Tom Bailey, and A.J. Tierson (with the Transitional Leader and stated clerk as staff support).

## Background

The stated clerk raised the question: Would it be in the presbytery's interest to engage an attorney to serve as the presbytery's counsel, with a retainer? The rationale is the recent and current involvement regarding potential dissolution of congregations and/or sale of buildings and other property.

The Transitional Leader will contact the attorney who has provided service to the presbytery regarding Fairville, Williamson, and Dundee.. Linda will inquire concerning his involvement in the past, and any payment for his services.

## (Commissioners to the 223<sup>rd</sup> General Assembly)

7. **Provide** the presbytery's General Assembly Commissioners and Young Adult Advisory Delegate with a short-term subscription to the *Presbyterian Outlook* (\$12.50 per month, each, for six months). This will provide helpful information for their preparation to serve as commissioners. The *Outlook* has provided this opportunity for the past several years.

## (Sponsorship of an International Peacemaker)

- 8. **Direct** the Budget & Finance Committee to reserve up to \$700.00 of Peacemaking Funds to support the visit of an International Peacemaker during 2018.
  - \$500.00 travel
  - \$200 300.00 for program expenses

#### <u>Background</u>

The General Council last year approved sponsorship of an International Peacemaker, but that didn't happen.

Such a sponsorship would be a good use for the Presbytery of Geneva's portion of the annual Peacemaking Offering. The presbytery's total Peacemaking Offering resources is currently \$1064.00.

A suggestion was made to consider having a presbytery-wide Peacemaking Banquet. Churches would be invited to name a "Congregational Peacemaker," who would attend the banquet (accompanied by congregation members) and be recognized. The International Peacemaker would be the keynote speaker. In addition to the banquet, congregations would be encouraged to invite the International Peacemaker to their church, in order to meet members of the congregation and to share her/his story.

#### (2018 Audit)

 Engage Heveron & Heveron to accomplish the 2018 presbytery audit. [The audit will be accomplished during April/May 2018.]

### (Dundee & Romulus - Building Sales)

The General Council considered the question, In their role as Presbytery Trustees, would the Trustees approve a request that the presbytery hold a mortgage for one or both of the buildings.

Following careful discussion of relative advantages and disadvantages, the General Council/Trustees VOTED to: **Authorize** the Administrative Commissions for Dundee and Romulus to explore all options for disposition of the buildings under their care, including the option of the presbytery holding a mortgage: pending review by legal counsel and review and approval by the Presbytery Trustees.

### **BUDGET & FINANCE COMMITTEE REPORT**

Tom Bailey reported that church pledge forms for 2018 need to be returned.

- Each year, after the budget is adopted, the presbytery sends a pledge form for a Per Capita Pledge and for a Mission Pledge. As of last week, 12 churches have not returned their pledge form. Please do that as soon as possible. We use the forms to project how our revenue will impact our expenditures.
- 2. We have separated designated funds from our operating checking account, by placing them in a savings account. We hope that by the end of this year we can end completely the co-mingling of our funds. A separate checking account has also been established for the Chinese Christian Fellowship.
- 3. We have designated the appropriate committees to disburse funds from the temporarily restricted funds.
- 4. The committee is reviewing the 2017 end-of-year reports and preparing for the annual audit.
- 5. We are operating on the principle that what each church gives is based on its own ability and commitment to the presbytery. We do ask you to make a commitment to per capita and mission based on your reported membership and the budget you have approved for the presbytery. We are all in this together.

## **Operating Results:**

Our results for 2017 will be audited in April and we have asked for the results to be ready before the General Council meeting in May. Our unaudited results show a growth of nearly \$24,000 cash. This

is the best number the Treasurer has seen since he got involved with Budget & Finance five years ago.

Last year, we were \$22,500 away from being solvent. Today we are well on the correct side of the solvency test. Besides increasing cash, we wrote down a phantom obligation (repayment of a Synod grant, which we no longer are obligated to repay). For the non-accounting types here today: we have more cash and securities than obligations—always a very good thing.

As a result of our long-term relationship with Community Bank, and our improved financial condition, Community Bank gave us an amazing deal on a conventional mortgage for the presbytery office building. Our monthly payment is now within \$50 of the old mortgage. Our equity in the building will continue to grow at a healthy pace. Once the building is sold, we will not only receive a nice check, but our monthly cash flow will improve by \$750 to \$1,000 a month, depending on how we replace our office and meeting facilities.

## Co-mingling of Funds:

Having separated other people's money from the operating Account, we have stopped co-mingling all of our funds except the Vittum Account. This is fare more than just a paper-play. Accomplishing this has freed the Committee on Ministry, the Committee on Preparation for Ministry, and the Mission Allocation Committee to restart programs that have been suspended for 4 years. This help has been critical. The Treasurer thanks the General Council for their cooperation, and for all those who have provided dedicated support. This growth in service is your gift to us all.

#### Trends:

Decline in membership continues, and may have accelerated slightly. Still, we have seen growth in our Mission Giving: \$5,000. The Treasurer has not examined the membership loss aspect of the formula, but does expect a five-year trend forecast that will be easier to live with.

#### **Current Cash Position:**

As of today, we have just over \$80,000 that we can use in the Operating Account. Of that total about \$19,000 is ours. There are no obligations standing in line for that cash. As small as the total "free cash" is, this is the first time in 5 years that the Treasurer has seen any cash that truly belongs to the presbytery.

## Huge Help from Penn Yan:

We are in this favorable cash position for several reasons. The Camp Whitman Advisory Committee understands that when they ask for funding for a special item, they are also drawing down Operating Cash, which is in short supply. The Treasurer's information is that the Committee hopes to avoid using the Operating Fund this year, just las our other committees have held off using their accounts during the past 4 years.

An urgent, unanticipated item did come up, regarding Camp Whitman, totaling between \$13,000 and \$15,000. The session of First Presbyterian Church, Penn Yan voted to cover that expense. What a huge and welcomed help!

The long-awaited settlement check from First Presbyterian Church, Williamson has arrived: \$11,000. The Budget & Finance Committee will recommend leaving that amount in the Operating Account. This would increase both the Operating Account balance, and provide more "free cash" for the presbytery. The Williamson settlement represents 3 years of per capita payments. [See the General Council Report to the presbytery regarding this recommendation.]

A review of the Accounts Receivable process has revealed the source of a problem that has been exaggerating our anticipated income for years. Four years ago, the Treasurer at that time fixed the numbers, but the process not yet been changed. The Treasurer and the Budget & Finance Committee are working on the *process* part of the problem.

The same flaw has resulted in our asking certain churches for mission support that is way out of line, which is both hurtful to those churches and damaging to the presbytery's relationship with them. As of now, our budgeting and budget management tools are all highly functional. If anyone receives financial items that don't make sense, please let the Treasurer know immediately!

## Our Churches Gift Us - We Don't "Bill" Them:

Our Transitional Leader has pointed out to the Budget & Finance Committee and the Treasurer that some of our current forms and letters are inappropriate, and are potentially harmful. The presbytery asked for a Transitional Leader who would help with relationship-building. Revising our pledge communications and follow-up materials will help greatly improve our relationships. Thank you, Linda!

### So in summary:

We have had a good year. Having said that, the Treasurer hopes it is obvious to everyone that an organization in financial decline with \$19,000in the bank that it can call its own, and a capacity to generate about \$25,000 a year in operations is not going to be able both to hire a person who wants to make a career managing the presbytery and operating the Camp at Seneca Lake at the same time. We are at that kind of moment. Many of our churches have lived through this sort of transition. For that reason, there is a great deal of practical wisdom around, as to how to build support so that decision does not have to be mad and about recognizing the fact that support has not materialized if that has become the Truth.

## **ATTACHMENT C**

## **Proposed Presbytery of Geneva Whistleblower Policy**

## **General**

The Presbytery of Geneva requires elected officers, leaders, and employees to observe high standards of business and personal ethics in the conduct of their duties and responsibilities. Employees and representatives of the Presbytery of Geneva must practice honesty and integrity in fulfilling responsibilities and comply with all applicable laws and regulations.

### Reporting Responsibility

It is the responsibility of all elected officers, leaders, and employees to report ethics violations or suspected violations in accordance with this Whistleblower Policy.

### No Retaliation

No elected officer, leader, or employee who in good faith reports an ethics violation shall suffer harassment, retaliation or adverse employment consequence. An employee who retaliates against someone who has reported a violation in good faith is subject to discipline up to and including termination of employment. This Whistleblower Policy is intended to encourage and enable employees and others to raise serious concerns within the Presbytery of Geneva prior to seeking resolution outside the Presbytery.

## Reporting Violations

The Presbytery of Geneva has an "open door" policy and suggests that officers, leaders, and employees share their questions, concerns, suggestions or complaints with someone who can address them properly.

For employees, the supervisor may be in the best position to address an area of concern and to recommend appropriate action. However, if a person is not comfortable speaking with the supervisor or is not satisfied with the supervisor's response, persons are encouraged to speak with someone on the Presbytery's Personnel Committee.

For elected officers and leaders, the Stated Clerk of the Presbytery may be in the best position to address areas of concern and to recommend appropriate action.

However, if a person is not comfortable speaking with the Stated Clerk or is not satisfied with the Stated Clerk's response, persons are encouraged to speak to the chair or vice-chair of the General Council, the Moderator or vice-Moderator of the Presbytery.

No individual should believe that there is no way to report a violation. Any person who has, in good faith made every effort to report ethical violations, but is uncomfortable with the response within the Presbytery, is encouraged to seek assistance from the Synod of the Northeast.

## Acting in Good Faith

Anyone filing a complaint concerning a violation or suspected violation must be acting in good faith and have reasonable grounds for believing the information disclosed indicates a violation. Any allegations that prove not to be substantiated and which prove to have been made maliciously or knowingly to be false will be viewed as a serious disciplinary offense.

### Confidentiality

Violations or suspected violations may be submitted on a confidential basis by the complainant or may be submitted anonymously. Reports of violations or suspected violations will be kept confidential to the extent possible, consistent with the need to conduct an adequate investigation.

## Handling of Reported Violations

Persons receiving reports will acknowledge receipt of the reported violation or suspected violation within seven days. All reports will be promptly investigated and appropriate corrective action will be taken if warranted by the investigation.

## Presbytery of Geneva Information Technology Disaster Recovery Plan

This document delineates the Presbytery of Geneva's policies and procedures for an Information Technology (IT) Disaster Recovery Plan, as well as our process-level plans for recovering critical technology platforms and the telecommunications infrastructure. This document summarizes our recommended procedures. In the event of an actual emergency situation, modifications to this document may be made to ensure physical safety of people, systems, and data.

Our mission is to ensure information system operation, data integrity and availability, and business continuity.

#### **Policy Statement**

- The Presbytery's comprehensive IT Disaster Recovery Plan shall be reviewed annually by the Personnel Committee and kept up to date to take into account changing circumstances.
- The IT Disaster Recovery Plan should cover all essential and critical infrastructure elements, systems and networks, in accordance with key activities.
- Staff must be made aware of the IT Disaster Recovery Plan and their own respective roles.

#### **Objectives**

The principal objective of the IT Disaster Recovery Plan program is to develop, test and document a well-structured and easily understood plan which will help the Presbytery recover as quickly and effectively as possible from an unforeseen disaster or emergency which interrupts information systems and operations. Additional objectives include the following:

- The need to ensure that employees fully understand their duties in implementing such a plan.
- The need to ensure that operational policies are adhered to within all planned activities.
- The need to ensure that proposed contingency arrangements are cost-effective.
- · Disaster recovery capabilities are applicable to staff, vendors and others.

### **Plan Overview**

## • Plan Documentation Storage

Hard copies of the plan will be stored in secure locations to be defined by the Presbytery Personnel Committee. Each member of the IT Disaster Recovery Team will be issued a hard copy of the plan and be asked to keep it offsite.

## Prevention and Backup Strategy

All attempts are made to prevent or limit the impact of a disaster on the information systems of our Presbytery. Key business processes and the agreed backup strategy for each are listed below. This strategy entails the maintenance of a fully mirrored duplicate site which will enable instantaneous switching between the live site and the backup site.

KEY BUSINESS PROCESS	BACKUP STRATEGY
Operations	Fully mirrored recovery in off-site location and cloud
Finance and Human Resources	Fully mirrored recovery site in off-site location and cloud
Email	Fully mirrored recovery site in off-site location and cloud
Disaster Recovery	Fully mirrored recovery site in off-site location and cloud

### **Emergency Response**

This policy and procedure has been established to ensure that in the event of a disaster or crisis, personnel will have a clear understanding of who should be contacted. Procedures have been

addressed to ensure that communications can be quickly established while activating disaster recovery.

- . Key trigger issues that would lead to activation of the IT Disaster Recovery Plan are:
  - Total loss of all communications
  - · Total loss of power
  - · Flooding of the premises
  - Loss of the building
  - Other situations as needed
- Plan Invocation When an incident occurs, the IT Disaster Recovery Plan may be implemented to:
  - Respond immediately to a potential disaster and call emergency services;
  - Assess the extent of the disaster and its impact on the Presbytery;
  - Decide which elements of the disaster recovery plan should be activated;
  - Establish and manage disaster recovery team to maintain vital services and return to normal operation;
  - Ensure employees are notified and allocate responsibilities and activities as required.
- IT Disaster Recovery Team members include:
  - Linda Badger Becker Transitional Leader
  - Alicia Alvarez Office Administrator
  - Rev. Val Fowler Stated Clerk
  - Lea Kone Camp Director
  - Russ Kinch IT and Technology Consultant

#### The team's responsibilities include:

- Establish facilities for an emergency level of service within 1 business day or as soon as possible;
- Restore key services within 1 business day of the incident or as soon as possible;
- Return to business as usual within 1 business day after the incident or as soon as possible;
- · Coordinate activities with disaster recovery team, first responders, etc.
- Emergency Alert

The person discovering the incident calls the Transitional Leader, Office Administrator, or Stated Clerk, in order of availability. Then the IT Disaster Recovery Team will be informed that an emergency has occurred.

· Personnel and Family Notification

If the incident has resulted in a situation which would cause concern to an employee's immediate family such as hospitalization of injured persons, it will be necessary to notify their immediate family members quickly.

#### Media Contact

The Transitional Leader or designee, will coordinate with the media. Only the Transitional Leader or designee is permitted direct contact with the media; anyone else contacted should refer callers or inperson media representatives to the Transitional Leader or designee.

- Media Strategies
  - Avoiding adverse publicity
  - Take advantage of opportunities for useful publicity
  - Have answers to the following basic questions:
    - · What happened?
    - How did it happen?
    - What are you going to do about it?

As part of the Presbytery's disaster recovery strategy, comprehensive liability coverage has been put into place. The Transitional Leader will contact the Insurance agency as soon as possible following the incident to apprise them of the incident.

## • Financial Assessment

The Treasurer and the Budget and Finance Committee of the Presbytery shall prepare an initial assessment of the impact of the incident on the financial affairs of the Presbytery. The assessment should include:

- Loss of financial documents
- Loss of cash and checks

### Financial Requirements

The immediate financial needs of the Presbytery must be addressed by the Treasurer in consultation with the Transitional Leader. These may include:

- Cash flow position
- · Temporary borrowing capability
- Upcoming payments
- Availability of Presbytery credit cards to pay for supplies and services required post-disaster

#### Legal Actions

The General Council will review the aftermath of the incident and may consult with an attorney to decide whether there may be legal actions resulting from the event.

### IT Disaster Recovery Kit and Supplies

An IT Disaster Recovery kit, including the following items, will be located at the Presbytery Office and off-site:

- Copy of the Presbytery's IT Disaster Recovery Plan
- Copy of the telephone numbers and email addresses for all members of the IT Disaster Recovery Team.
- Copy of telephone numbers with extensions and email addresses for all staff and the General Council.

## • IT Disaster Recovery Incident and Activity Report

- On completion of the initial IT disaster recovery response, the Office Administrator, in consultation with the Transitional Leader will prepare an incident report of the disaster and the activities undertaken.
- The report should contain information on the emergency, who was notified and when, action taken by members of the IT Disaster Recovery Team together with outcomes arising from those actions.
- The report will also contain an assessment of the impact to normal business operations and lessons learned
- A copy of the report will be provided to General Council and the Personnel Committee of Presbytery.

## **ATTACHMENT E**

## **Presbytery of Geneva Conflict of Interest Polity**

The Presbytery of Geneva has adopted its conflict of interest policy to assist the Presbytery in carrying out its duties and responsibilities in an ethical manner while also protecting the integrity of the organization as a whole.

The Conflict of Interest Policy covers all interests which may influence an elected person's or a staff person's duties and responsibilities. The Policy covers instances where there may be a personal benefit or the avoidance of personal loss.

A conflict of interest is any situation in which a personal interest may be incompatible or in conflict with one's responsibility in a Presbytery position. Membership in another organization

may, or may be perceived to, influence carrying out one's duties and responsibilities.

Conflicts of interest may be real - that is, an interest that may influence one's duties and responsibilities; or potential, in that it could influence; or apparent, where there are reasonable grounds to believe there may be a conflict even if, in fact, there is none.

To avoid real, potential, or apparent conflict of interest situations, elected leaders and staff members will:

- declare a real, potential, or apparent conflict of interest and the nature of the conflict, at the earliest opportunity
- refrain from discussion, debate, and voting in matters where a real, potential or apparent conflict may exist
- not attempt in any way before, during or after the meeting to influence the voting
- not discuss anything in relation to any decision taken on the matter outside of the meeting

Should an elected leader violate the above Policy in any way, the General Council may exercise one of the following options:

- issue a verbal or written reprimand
- request resignation
- · recommend to the Presbytery that the election be rescinded

Should a staff member violate the above Policy in any way, the Personnel Committee of the Presbytery may exercise one of the following options:

- issue a verbal or written reprimand
- request resignation
- recommend termination

## **OVERTURE 006** – With original rationale

On Directing the Board of Pensions and the Foundation to Divest from Fossil Fuel and Actively Invest in Securities that Focus in Renewable Energy—From the Presbytery of Hudson River.

The Presbytery of Hudson River overtures the 223rd General Assembly to

- 1. Commend the Board of Pensions and Presbyterian Foundation for creating fossil free options for participants, and the Mission Responsibility Through Investment Committee for increased engagement with companies in the Fossil Fuel industry-- actions that embody the beginning of a faithful response to the devastating and urgent reality of climate change.
- 2. Recognize that by continuing to hold investments in the fossil-fuel companies that most egregiously contribute to the climate crisis, the PC(USA) is complicit in harming God's creation and "the least of these" who are disproportionately affected by climate change.

- 3. Direct the Board of Pensions and the Presbyterian Foundation to divest from the fossil fuel industry.
- 4. Direct the Board of Pensions and the Presbyterian Foundation to actively seek out and invest in securities of companies whose predominant focus is in renewable and/or energy efficiency.
- 5. Direct the Board of Pensions and the Presbyterian Foundation to report to the 224<sup>th</sup> General Assembly (2020) about their progress in effecting recommendations 3 and 4.

#### Rationale

People on the front lines of climate change, particularly people of color, are disproportionately impacted by climate change. Countless individuals and organizations among "the least of these" have prophetically called upon the world to divest from fossil fuels. Earlier this year, for example, Ladonna Brave Bull Allard, one of the Native Water Protectors at Standing Rock said, 'We will be everywhere to let people know that there's a better way to live, there's a better way to live with the Earth, with green energy, and that it's time for us now to start divesting from fossil fuel, because we must save the water. We must save the water." We are thus called to take prophetic action in light of these voices and the imminent dangers on which they shed light.

The PC(USA) has debated divestment from the fossil fuel industry during the last two General Assemblies (221st in 2014 and 222nd in 2016).

In 2014, the Presbytery of Boston sent the overture "On Divestment from Fossil Fuel Companies" with 11 presbyteries concurring.

In 2016, the Presbytery of San Francisco sent the overture "On PC(USA) Fossil Fuel

Divestment" with 31 presbyteries concurring.

Prior to the 222<sup>nd</sup> Assembly, nine former moderators signed a letter urging the commissioners to support the overture to divest. <sup>1</sup> Their reasoning included, "because of the grave and urgent threat of climate change and the fossil fuel sector's well-documented and unyielding refusal to change, it is no longer morally or ethically right for the PC(USA) to profit from companies that are creating ecological destruction and human suffering on such a monumental scale."

Our denomination has already recognized the moral mandate for humanity to shift to a sustainable energy plan in a way that is both just and compassionate, not least of which includes the support of carbon neutrality in 2006. These statements have all been founded on the biblical call to love and care for creation.

We have actively worked as a denomination to reduce our use of fossil fuels and shrink our carbon footprint in our congregations and individual lives. These biblical and denominational mandates compel us to look at our collective investments.

As a denomination, we have long held that we cannot profit from the companies whose policies are harmful to any living thing. For nearly a century, the church has not invested in companies producing alcohol, tobacco, gambling, the military, or those that contribute to violations of human rights. The General Assembly thus declared in 1968, "the [Church's] power to spend and to invest includes the power to refrain from

spending or investing. The church has not only the right but the responsibility to be selective in the use of its funds."

The General Assembly reinforced this form of stewardship in 1992, affirming that it does not and will not invest in any "sin stocks." In addition to these broad industries, General Assemblies have also divested from the Duke Energy coal mining company because of its treatment of its workers, Chevron after it sold fuel to the South African apartheid government, Talisman Energy for building a pipeline in Sudan that threatened human rights, and Hewlett Packard, Caterpillar, and Motorola for profiting from human rights abuses in the occupied Palestinian territory.

Some of these divestment actions came after a long process of corporate engagement by the church's Mission Responsibility Through Investment (MRTI) committee. Other divestment decisions were made outside the realm of MRTI.

Climate change represents deep harm to the whole biosphere, including especially marginalized people, so it is imperative that we would divest from the industry most responsible for that harm, as outlined in the Carbon Underground  $200^2$  list

And already as a denomination we are taking some steps. The Foundation has introduced financial products that provide comparable return on investment without supporting fossil fuel companies, and the Board of Pensions has a fossil-free option for their 403-B plan. Synods, presbyteries, congregations and individuals have moved their investments to such funds, and we commend them for doing so.

But while these actions among individuals and various Presbyterian entities are faithful responses to the growing crisis of climate change, they fall far short of the institutional actions necessary to make a significant difference. It is time for fossil free investments to be the norm instead of the option.
