The moderator called for brief expression of good news in the lives of churches in the Presbytery of Geneva.

The presbytery celebrated the Peacemaking Banquet, held in Seneca Falls on Friday, September 21. Twelve congregations named Congregation Peacemakers, who were honored. Almost 100 people were present.

The presbytery shared the news that Dick Evans was taken to the hospital this morning, for assessment and observation.

The presbytery VOTED to make the Small Church Network report the next item of business so that presenter Marty Evans would be free to leave, to be with her husband.

SMALL CHURCH NETWORK REPORT: Burdett Presbyterian Church, Burdett, NY

Marty Evens noted that the Burdett church hosted the March 2018 gathering of the Small Church Network. That meeting confirmed for her the ability of small churches to **persevere**.

On February 14, 1826, seventeen people decided to form a church. For ten years, they worshiped in many buildings in the community, including homes. After that first ten years they were able to erect a sanctuary.

The Burdett church has a long history of mission. Mission is long-rooted in the church's history. Marty found some records of the congregation's mission giving through the successive years, commenting, "Translated into current dollars, the giving of our little congregation is astounding."

She found a grave stone in the cemetery, with the slogan, "Born a slave ... Died free." The woman whose grave is so marked was one of the persons Harriet Tubman led to freedom. She came to Burdett through the Underground Railroad.

The last person buried in the cemetery was the first mechanical engineer to graduate from Georgia Tech. Researching his name (he was a member of the Burdett congregation) she learned that he had a full, productive, and inspiring career which touched hundreds of lives. "I will sum this report up by saying, Be inspired by your roots."

Joann Braun led the presbytery in prayer for the Evans family.

GENERAL COUNCIL REPORT, Part 1

John Gingerich, Chair, presented the report of the General Council. He announced that the *Service of Dissolution* of the Almond Union of Churches as a PCUSA congregation will be held on Sunday October 14, 2018 at the Almond Church, at 10:30 a.m. He offered an invitation to attend to all who are able.

GENERAL COUNCIL REPORT TO THE PRESBYTERY September 25, 2018

First Presbyterian Church, Watkins Glen, NY

[From the regular meetings of 06/12, 08/14, 09/11 and the 08/07 special meeting.]

ITEMS FOR THE PRESBYTERY'S ACTION

The General Council VOTED to recommend that the presbytery: There were no items before the General Council that require presbytery action.

ITEMS FOR THE PRESBYTERY'S INFORMATION

The General Council VOTED to:

(Request to the Synod for Original Jurisdiction)

 Request the Synod of the Northeast to assume original jurisdiction of the disciplinary case involving allegations against a member of the Presbytery of Geneva; and direct the stated clerk to transmit this request to the stated clerk of the Synod of the Northeast.

NOTES:

(a) The details of this request are, by necessity, confidential to the General Council.

(b) The stated clerk transferred the request—along with all supporting information for the request—to the stated clerk of the Synod of the Northeast, by certified mail/return receipt requested.

(c) The stated clerk received confirmation of receipt of the request.

(d) As of the date of preparation of this report, the stated clerk has not received notification as to whether the request has been granted by the Synod.

(Transitional Leader: Compensatory Time and Vacation)

2. **Grant** the Transitional Leader two weeks of vacation in July, plus an additional three weeks of compensatory time, comprising July 1 through August 4, 2018.

Background & Rationale

The Transitional Leader is engaged at 60% time (26 hours per week). Events in February and March (including two major issues and the death of a Commissioned Ruling Elder) required significant time beyond the parameters of the position. The above dates are the best way to make up for those additional hours, at minimal impact on the working of the presbytery. The Transitional Leader is hired by the General Council and supervised through the Personnel Committee, so the recommendation needs concurrence of the Personnel Committee.

(Check-Signing Authorization)

 Continue Rob Anderson's authorization to be one of the two check-signers on behalf of the presbytery, even after he leaves service on the General Council. [NOTE: This action came by request of the Budget & Finance Committee.)

(Annual Audit)

4. Receive the Audit Report for the 2017 financial year.

The Annual Audit, conducted by Heveron & Heveron, has been completed. The General Council reviewed the cover letter and the summary report. The audit found no material weaknesses in the financial management of the presbytery. All of the special funds have been restored, and faster than was initially anticipated.

The General Council offered its gratitude to the Budget & Finance Committee for their diligent and excellent work on behalf of the Presbytery.

(November Presbytery Meeting)

4, **Accept** the invitation of First Presbyterian Church, Bath, NY to host the November 17, 2018 stated meeting of the Presbytery of Geneva.

(Special Presbytery Meeting – October)

5. **Call** a special meeting of the Presbytery of Genesee Valley for Tuesday October 23, 2018, 9:30 a.m. through 2:00 p.m., for the purpose of engaging in strategy work (possibly including structure and staffing of the presbytery). If the way be clear, the location will be Bellona Presbyterian Church.

(Camp Whitman / Executive Coaching)

6. Approve a grant of \$1,000 from the Vittum Fund to Lea Kone for a second year of executive coaching. She has completed a year of executive coaching through the PCUSA Camp and Conference Center Program. The Executive Coaching is designed specifically for camp and conference center directors. The request came through the Camp Whitman Advisory Committee.

(Camp Whitman / Camp Renovations)

- 7. Authorize the Camp Director to employ donated funds and anticipated donations to begin the firststage renovation project, which will include the floor of the lodge and new tables and chairs for the lodge.
- 8. **Authorize** the Camp Director and the Camp Whitman Advisory Committee to begin fund-raising for the remainder of the renovation project funds.

Background and Rationale

The appraisal of the Camp Whitman property has been completed. The total property is valued at \$1.75 million (as-is). A significant part of that value is the waterfront. The property is currently zoned for seasonal use (not year-round). The appraisal confirmed that the best use of the property is recreational use.

The Camp Director shared information about an initial renovation project (involving improvements to the lodge, and improvements to the cabin areas). The cost would be \$200,000, and very soon the presbytery will receive almost \$100,000 toward the renovation project (a portion coming from the sale of the Laurelton Presbyterian Church, Rochester, NY property).

The Run River consultants have been invited to attend the September meeting of the General Council.

(Camp Whitman Membership Association)

- 9. Authorize the formation of a *Friends of Camp Whitman Association* to be made up of persons committed to seeing the success of Camp Whitman.
- 10. **Direct** The Camp Whitman Advisory Committee—along with interested General Council members—to develop the plan for implementing a *Friends of Camp Whitman Association*, and communicate those plans to the General Council prior to implementation.

Background & Rationale

This action was taken after much discussion. The Transitional Leader reviewed the assessment of the Run River Consultants:

There is no long-term future for Camp Whitman unless

- 1. The facilities are upgraded. [In June, the General Council approved an initial #200,000 upgrade of the lodge and some of the cabins, as a start. Most of the money is in hand; some will need to be raised. The initial project for improvement of the Lodge was delayed by the start of the 2018 camp program.]
- 2. Steps are taken to bring the service of the Camp Director to full-time.
- 3. Significant volunteer support is developed.

The proposal for a *Friends of Camp Whitman Association* was conceived as a way of developing a financial support base, as members might join the Association with an annual payment (\$65 was offered as a suggestion). Those persons would also provide a contact base for encouraging further support of Camp Whitman, by increasing opportunities for their volunteer service to the Camp, or by facilitating their outreach to persons who might volunteer their service to the Camp. The \$65 donation was suggested in recognition of the approaching 65th Anniversary of Camp Whitman.

(Camp Whitman: Logging Proposal)

11. **Approve** the recommendation of the Camp Whitman Advisory Committee for logging; and **directed** that the proceeds of the logging project initially be placed in the Operating Fund, with any remaining balance to go to the Capital Fund for Camp Whitman improvements. [Background and Rationale: see Activity Report below.]

Background & Rationale

Dugan Creek Lumber is proposing a selective harvesting on Camp Whitman. All trees of significant monetary value will be harvested, with the exception of any trees or areas designated by the camp. All harvested trees will be pulled to specific landing areas that will be shown and approved by the Camp Director. After trees are in these areas, and independent buyer will be chosen by Dugan Creek. The buyer at the time will selected according to whomever is currently paying the highest market price.

After the log sale, Camp Whitman will receive 60% of the total value of the harvested trees, with the remainder going to Dugan Creek Lumber. At the conclusion of the sale, Jason Klemmer (principal owner) will walk and inspect the camp grounds to make sure work is satisfactory. Before any harvesting, Dugan Creek's proof of insurance will be forwarded to Camp Whitman.

They estimate that our profit from timber sales could be upwards of \$40,000 - \$50,000.

(Camp Whitman Advisory Committee)

12. Appoint the Rev. Leah Ntuala as a member of the Camp Whitman Advisory Committee.

(Presbytery Office Building)

13. Authorize reducing the advertised price of the building to \$225,000. The vote was 9/4.

14. Establish \$202,000 as the lowest acceptable sale price for the building. [There was one "no" vote.]

Background & Rationale

The realtor for the sale of the Presbytery Office Building has suggested a reduction of \$25,000 in the asking price for the building. The Budget & Finance committee has suggested an additional \$10,000 negotiating room. The General Council must act on those requests before they can be implemented.

During the discussion, it was noted that:

- The layout of the building is not easily managed.
- There are several building issues that have needed attention.
- The mortgage payments and building maintenance cost the presbytery @\$29,000 per year
- The original purchase price was \$202,000

(Invitation to General Assembly Moderator)

15. **Authorize** the Transitional Leader to submit the application extending the invitation to the comoderators of the 223rd General Assembly (or one of them) to visit our presbytery at a date convenient to them.

(PCUSA Presbytery Moderator Training)

16. **Send** moderator-elect to the PCUSA Moderator Training event in October 2018, if the way be clear (if funds are left in the General Assembly budget line). This will prepare the moderator-elect for service as moderator.

(Authorization for Check Signers)

- 17. **Remove** the name of the previous Treasurer from the list of check-signers.
- 18. Add Phoebe Baker to the list of check-signers, in light of Donna Colvin's current recuperation period.

(Synod Meeting – Young Adult Advisory Delgate)

19. If the way be clear, **provide** the cost of a hotel room for the Young Adult Advisory Delegate to the Synod meeting to attend the Anti-Racism Training the day before the Synod meeting. Virginia Champlin will ask the session of Geneva Presbyterian Church (of which the YAAD is a member) to provide the support if the presbytery cannot.

(Lodi Flooding / PDA Grant)

- 20. Authorize the Chair of General Council and the Transitional Leader to administer the PDA grant.
 - An idea from the Lodi church is to use a portion of the funds to replace appliances that were lost in the flooding.
- 21. Announce that the Presbytery of Geneva will receive funds for Seneca Lake Recovery.
 - Donations received through the presbytery will be placed in this special fund, which is separate from the PDA grant. If funds remain from the PDA grant, they will be transferred to the Seneca Lake Recovery fund.
- 22. **Direct** that the offering received during the September 25, 2018 stated meeting of the presbytery be designated to the Seneca Lake Recovery fund.

Background & Rationale

During a recent storm, serious flooding occurred along the east side of Seneca Lake, taking out most of Lodi Point. In response to a request from the Lodi Presbyterian Church, the Transitional Leader

secured a \$7,500 grant from Presbyterian Disaster Assistance (PDA). Three Presbyterian churches were very involved in the immediate response efforts: Lodi, Hector, and Ovid (Ovid was an emergency shelter location).

A PDA team will visit Wednesday through Sunday of this week, and will participate in worship in the three churches. Thursday morning, led by the Rev. Rob Mellgard, the team will tour the damaged areas.

(Additional Hours Allocation for Camp Whitman Director)

- 23. **Approve** an additional 75 hours of work for the Director of Camp Whitman through the end of the year.
 - The additional hours will be related to the renovation work being done at Camp Whitman, and work related to the Capital Campaign for Camp Whitman.
 - The cost of the additional hours (compensation and Board of Pensions) will be approximately \$2,500 and will come from the Camp Whitman Budget (and, if necessary, from the Vittum Fund).

(2019 Per Capita)

24. Keep the 2019 Per Capita request at \$50 per member: the same as 2018. (There was one NO vote.)

NOTE: The Budget & Finance Committee will propose a Temporary 2019 Budget which will follow the 2018 Budget until the 2019 situation is clearer.

RUN RIVER PRESENTATION ON CAMP WITMAN

During the September 11, 2018 meeting, the General Council welcomed the Rev. Pam Harris and the Rev. Gary Stevens of Run River Associates, who have been working with the Camp Whitman Advisory Committee and leaders of the Presbytery of Geneva and the Presbytery of Genesee Valley for the past year.

Pam and Gary noted that their final retreat with the Committee and leaders will be tomorrow, September 12, 2018.

The General Council received the report, Strategic Planning for Camp Whitman.

Some highlights of their report include:

- "You have one of the most spectacular settings for such a ministry that we have ever seen, both in terms of the aesthetics of the property and the theological opportunities the property provides."
- All of the sustainability needs of the camp are possible; we discovered no "hard obstacles."
- **Most important**: To discover a depth of mission beyond the current sense that "We have Camp Whitman because we have had Camp Whitman, and because we have always had Camp Whitman."
- "You can really dig deep for a purpose: it is hidden in the land, hidden in the waters, and hidden within who you are. It is also hidden within your recently-stated purpose and vision."
- With respect to the purpose and vision: "How does Camp Whitman help us accomplish the purpose and the vision for the Presbytery of Geneva?"
- "In short, you have a magnificent resource, with incredible potential to help the presbytery and its congregations to do what they are called to do."

The General Council engaged a "walk through" of the Strategic Planning Report.

- "We have discovered in Presbyterians an important link between faith and science, faith and nature. This will be a huge help in discovering the purpose for the camp, and in moving forward."
- Amidst the amazement at the spectacular property is the un-amazing nature of the facilities. The Dining Hall is the only part of the facilities that is structurally sound and has a minimal long-term future (and that future is minimal because it is in the wrong place, and stands in the way of the spectacular view of the lake as one enters that part of the property).

• The current cabins are essentially "garden sheds." The Report includes suggestions for improvement of the current cabins, with an eye toward their replacement in the future.

The General Council discussed opportunities and means for placing the Run River report before the presbytery, and engaging wider vision for Camp Whitman.

The Rev. Leah Ntuala, newly-appointed member of the Camp Whitman Advisory Committee, offered a presentation on Camp Whitman Strategy. She noted that the Run River consultants have shared with the General Council the things that must be done over the next three years, if Camp Whitman is to survive and thrive.

- 1. Significant improvements and expansion of facilities.
 - a. Cabins: upgrades and rebuilding
 - b. Composting toilets
 - c. Upgrades to the Lodge, some of which are occurring now (the floor, replacement of tables)
- 2. Move to a full-time Camp Director. This is important for management, for interpretation, and for development.
- 3. Significant re-engagement of Volunteers and Donors.

She encouraged all to participate in the Fall Festival, October 13, 11:00-4:00 at Camp Whitman.

She encouraged churches to consider receive a special offering for Camp Whitman on a Sunday (or two ... or three).

One congregation shared that while the do not have campers in their church, they annually sponsor campers from their community.

COMMITTEE ON REPRESENTATION

Elder Mark Smith presented the report of the Committee on Representation.

The Committee has been meeting for two years. Their theme has become, "Won't you be my neighbor?" (with a nod to Mr. Rogers). This is because much of the Committee's work and conversation has essentially been framed by the concept of extending ourselves to our neighbors, and even expanding the awareness of who our neighbors are.

September 15 through October 15 is Hispanic Heritage Month. As with other such celebrations, the Committee has researched resources and provided links on the presbytery web site.

The Committee is currently working on resources regarding immigration.

PRESBYTERIAN WOMEN

Elder Virginia Champlin presented the report of the Presbyterian Women of Geneva Presbytery.

Three persons attended the Church Wide Gathering of Presbyterian Women, held in Louisville, KY.: Sabrina Slater (who was on the planning committee for the event), Linda Werts, and Virginia Champlin.

Linda and Virginia attended the pre-Gathering event on preparedness training for natural disasters. Gail Farnham (a member of the Presbyterian Disaster Assistance Committee as well as a member of First Presbyterian Church, Ithaca) provided part of that training.

The presbytery's Presbyterian Women Fall Gathering will be held on October 27, 2018 at Ontario Center

223rd GENERAL ASSEMBLY

The Rev. Glenn Kennedy (Painted Post, Vice-moderator) Elder Linda Werts (Newark, Park) YAAD Cherokee Lane (Palmyra, Western)

Linda Werts presented the report. The Theme of the 223rd General Asssembly, held in St. Louis, was "Kin-dom Building for the 21st Century."

She celebrated the faithful leaders that we have for the Presbyterian Church USA—one of the "awarenesses" that grew in her during Assembly week, through her interactions with those leaders and her observations of their work.\

The 2020 Committee laid before the denomination the vision that we will become the PCUSA: **P**owerful, **C**ourageous, **U**nited, **S**erving, **A**live.

Linda thanked the presbytery for providing the opportunity to serve as a Commissioner.

The presbytery joined in singing the theme hymn of the Assembly, "Draw the Circle Wider."

DOCKET

The stated clerk announced that the presbytery was almost one hour ahead of the docket. The presbytery VOTED to complete the remaining business before lunch, and following lunch to gather for the Resolution of Thanks and the closing worship service.

Internal Business: "...The Presbyery of Geneva Lives...." Part 2 BUDGET & FINANCE / TREASURER

Elder Tom Bailey presented the report of the Budget & Finance Committee

The August year-to-date financial report shows a nice surplus in the presbytery's financial balance. BUT, we have a ways to go. He encouraged all congregations to be faithful in their commitments to the support of the presbytery.

The Budget & Finance Committee, with the agreement of the General Council, has decided to keep the current budget for 2019, at least until the presbytery has determined what our future is. The remaining Transitional Process includes developing the presbytery's Strategies and Staffing Pattern. It makes sense to continue the 2018 budget, until those directions become clearer.

The per capita amount will remain \$50 per member. There may be an increase in the future, but for now the amount will remain the same.

The Budget & Finance Committee is reviewing the presbytery's Financial Polices, which were approved in 2016. The Committee will be recommending some needed changes to the presbytery.

REPORT OF THE TRANSITIONAL LEADER

Linda Badger Becker noted that her report is two sections:

Presbyterian Disaster Assistance

On Tuesday August 14, 2018 a strong storm caused extensive damage on the eastern shore of Seneca Lake, from Lodi Point to Sheldrake. Many homes were seriously damaged; some were later condemned.

The response of Presbyterian Churches in that area was inspiring. Ovid provided a shelter for victims of the storm, also providing food and clothing. The congregation also interfaced with the Fire Department in their response to the disaster.

Through Interim Pastor Barbara Schwartz (Hector and Lodi), and with the assistance of the Transitional Leader, the Lodi and Hector churches helped obtain a \$7500 Disaster Assistance Grant from Presbyterian Disaster Assistance. Linda noted that PDA is not a "first responder;" they help with the recovery, and will work with the congregation to maximize the effectiveness of the grant.

Very shortly after the disaster, representatives of PDA—one of whom was our own Gail Farnham—made an on-site visit. They visited with the Ovid, Lodi, and Hector churches and toured Lodi Point. **Seventy** homes have been condemned as a result of the storm; most of them are permanent residences, and some are over 100 years old.

There is a line item in the presbytery Designated Funds: Presbytery Disaster Fund. Special offerings or donations will be directed to that Fund, which will be separate from the PDA Grant.

Transition Process

Linda led the presbytery in reading the Purpose Statement (showing a picture of the recent Peacemaking Honorees) and the Vision Statement (showing a picture of Sue Goodrich, who was honored during the May presbytery meeting for her life time of radiating the light of Christ through her service to the Presbyterian Church).

The next phase of the Transitional Work is **STRATEGY.** The General Council has prepared a recommended Strategy (WHAT we plan to do and WHO will do it). This strategy will be presented to the Special Meeting of the presbytery on October 23.

The last step is **STAFFING**. This step follows the strategy. The Council's goal is to present to the presbytery a staffing design during the November stated meeting of the presbytery.

Linda honored the diligent and faithful work of the General Council through this process, which began a little more than a year ago.

ATTACHMENT B

Pastor emerita/emeritus Guidelines and Requirements

The following guidelines and requirements provide congregations of our Presbytery with a healthy and uniform process for granting emerita/emeritus status to retired pastors.

It is important to emphasize that this is an honorary title with no inherent pastoral duties or authority and no compensation. Such a designation does not release a pastor or congregation from the obligation to maintain healthy boundaries as required by the Book of Order and the Committee on Ministry (COM).

G-2.0905 After the dissolution of the pastoral relationship, former pastors and associate pastors shall not provide their pastoral services to members of their former congregations without the invitation of the moderator of the session. *The Constitution of the Presbyterian Church (U.S.A.) Part II Book of Order*

Since this is an honorary relationship built upon gratitude and affection of a congregation for their pastor or associate pastor, the COM *ordinarily* requires that there has been a pastoral tenure of 10 years prior to consideration of pastor emerita/emeritus status.

A congregation should *ordinarily* wait a minimum of one year to request of COM that pastor emeritus/emerita status be conferred. Exceptions to this time limit may be made when necessary, such as ill health of the retiring pastor.

The session shall make a formal written request to the COM with accompanying rationale for conferring this honor on a former pastor. Session representatives *may* be asked to attend a Committee on Ministry meeting to interpret the request.

Following COM's approval, the congregation at a duly called congregational meeting may elect the retired pastor or associate pastor emeritus or emerita. It is important to carefully interpret that the title is honorary with no inherent pastoral duties or authority and no compensation.

The action of the congregation requires approval by the Presbytery of Geneva.

Following all of necessary approvals, it is appropriate to arrange for a worship service to celebrate the election of this honorary relationship.

ATTACHMENT C

Promoting Healthy Boundaries Between a Departing Pastor and a Congregation

G-2.0905 After the dissolution of the pastoral relationship, former pastors and associate pastors shall not provide their pastoral services to members of their former congregations without the invitation of the moderator of the session. *The Constitution of the Presbyterian Church (U.S.A.) Part II Book of Order*

The Book of Order requirement provides a base line for promoting healthy boundaries between departing pastors and congregations. Such boundaries exist to help both pastor and congregation recognize that there has been a significant change in the relationship. Upon dissolution, the role is no longer that of pastor, though friendships may remain. It is important for both a former pastor and congregation members to maintain healthy boundaries and to distinguish between friendly relationships and pastoral relationships.

Because this Book of Order requirement is sometimes misinterpreted, it is important to emphasize that any invitation to provide pastoral services must come from the moderator of the session, not from members of the congregation nor even the session itself. Therefore, it is assumed that the former pastor will always politely decline invitations from congregation members to perform any kind of pastoral services including preaching, weddings, baptisms, funerals, hospital visitation, etc. The moderator of the session has the right and responsibility to determine when it is appropriate for the former pastor to participate in a pastoral role. There is no time limit on this restriction.

The Committee on Ministry has the responsibility to insure healthy transitions for pastoral leaders and for the congregations they have served. Navigating the relationship between a former pastor and a congregation is challenging depending on the length of tenure, the circumstances of the dissolution, and the duration of the interim period between pastoral leadership. This is especially problematic when the pastor is remaining in the community where the church is located. Because people and circumstances are unique to each situation, the exact nature of the boundaries between the pastor and the congregation may indeed vary.

The Committee on Ministry needs to be aware of these unique dynamics of the situation in order to offer guidance, and, if necessary, to set forth specific requirements or restrictions. In other words, there is no one standard that can be applied to every situation.

Therefore, prior to the dissolution of any pastoral relationship, a team of Committee on Ministry representatives shall meet with the Pastor and Session to clarify the Book of Order requirement and to discuss other necessary boundaries for that situation. Ongoing communication with the Committee on Ministry will be important during the transitional period.

In most cases, the departing pastor will be asked to refrain from attending any activities at the church, including worship, for a minimum of one year in order to enable the congregation to adjust to the change in leadership. Departed pastors who have retired or have not received another call to a congregation are encouraged to seek worship and fellowship in another congregation.

To prevent misunderstanding and to assist with interpreting healthy boundaries to congregation members, a written agreement will be signed by the Clerk of Session and the departing pastor, and approved by the Committee on Ministry. This covenant will be shared with the congregation prior to the last day of service. The Book of Occasional Services offers an excellent Service of Dissolution of a Pastoral Call which can take place as part of worship on the pastor's last Sunday of service.

SAMPLE Agreement Between Congregation and Departing Pastor:

The Committee on Ministry has the responsibility to insure healthy transitions for pastoral leaders and for the congregations they have served. It is important for both a former pastor and congregation members to maintain healthy boundaries and to distinguish between friendly relationships and pastoral relationships.

Therefore, the Session of _____and (pastor's name) understand that the following boundaries go into effect when

_____ is no longer called to serve the congregation.

In compliance with the requirement stated in the Presbyterian Church (U.S.A.) Book of Order G-2.0905: After the dissolution of the pastoral relationship, former pastors and associate pastors shall not provide their pastoral services to members of their former congregations without the invitation of the moderator of the session.

____ will no longer provide pastoral services to the congregation, corporately or individually, without the

expressed invitation of the moderator of session assigned by the Committee on Ministry. Therefore, ______ will

always politely decline invitations from congregation members to perform any kind of pastoral services including preaching,

weddings, baptisms, funerals, hospital visitation, etc. All requests for pastoral services should be directed to

In addition, ______ will refrain from attending any activities at the church, including worship, for a period of

While letting go of the pastoral relationship and role is a challenging aspect of transition, we understand that there is important wisdom and faithfulness in honoring this agreement.

Commissioned Ruling Elder Formation Program Section IV EDUCATIONAL PROCESS PART 1: Classroom

Amendments approved on September 25, 2018. Changes/additions are noted in italic print.

A. Classes

1. One option for formal classes is offered in partnership with Colgate Rochester Crozer Divinity School (CRCDS) through the **School for Christian Leadership**. CRE Candidates must apply and be accepted into the program by CRCDS. Students must meet all requirements for the program. Students are responsible for all fees set by the program.

The candidate may enter the educational process at any point allowed by the CRCDS program.

- 2. Formal classes will be supplemented by Experiential Learning and seminars/discussion groups.
- 3. Evidence of satisfactory completion of each course is required. Should a CRE candidate not satisfactorily complete a class, it will be the prerogative of the Committee on Preparation for Ministry to assess the student's progress and determine whether the class will need to be repeated or whether an alternative method of remedial study and demonstration of proficiency will be possible.

School for Christian Leadership

A three-year Certificate Continuing Education program to train Chrsitian leaders for the 21st Century Church.

The School for Christian Leadership program is designed to prepare persons for various kinds of parish ministry, such as deacons and/or locally ordained priests in the Episcopal Church, Commissioned Lay Pastors, Lay Preachers, or other designated titles.

Those who take the full three year cycle will be awarded a certificate by CRCDS at Commencement in May of the third year of the program. Application for Continuing Education Unit (CEU) credits may be made to the CRCDS Registrar for a nominal fee.

The program will meet one Saturday per month, beginning in September and concluding in April each year. Classes will be held on the CRCDS campus and will be taught by CRCDS Faculty and Faculty Associates. Breakfast and midafternoon hospitality on Saturday is included in the tuition.

This program is alternatively being offered online.

Christian leaders who do not wish to enroll for the full Certificate Continuing Education Program may choose to enroll

for individual Saturdays. These students are not required to write papers or take examinations, but are expected to do the reading assigned for the day in order to participate fully in the class. The individual Saturday option is dependent upon remaining space available and subject to permission of the instructor.

4. A second option for formal classes is being offered in partnership with Union Presbyterian Seminary (Richmond, VA) through the Pathways to Learning and Leadership Institute.

Specifically designed for CRE programs, nine courses are offered over a two year period, four foundational courses and five practical courses. They are:

The guiding principles in creating the courses are, first, that they are be accessible and affordable, of excellent quality, and flexible for the presbyteries. To that end:

- All courses are online—they can be taken from anywhere, without concerns for travel, lodging, and being away from family, work, and church responsibilities.
- Each course is five weeks long (two hours a week online, about two hours of reading and study, and about two hours of homework), for a total of 30 hours.
- Each Five-week course costs only \$100, plus the purchase of one book—other readings are made available at no cost.
- Courses are led primarily by Union Presbyterian Seminary professors; a few are led by excellent experienced practitioners.
- Courses are not graded; we inform the presbytery when someone has successfully completed a course.

In response to requests from some of our presbytery partners, additional courses are sometimes offered.

BACKGROUND & RATIONALE

The current CRE Formation Program was approved by presbytery in 2015. At that time the CRCDS *School for Christian Leadership* was a new opportunity for meeting the educational component of a CRE program. It then was only offered on-site. The School for Christian Leadership was, and is, an excellent educational opportunity. However, it is only offered on Saturdays, and costs (with required materials) in excess of %5,000. It remains the preferred educational program of the Presbytery of Geneva Committee on Preparation for Ministry, and has been recommended highly by those who have completed it.

Since 2015, it has become evident that limiting the CRE educational requirements to this single option has been a factor in persons not choosing to enter the CRE program. Even though there have been several inquiries, there have been no new entrants into the program in three years. Education schedule conflicts and cost have been cited among reasons inquirers have not entered.

More recently, two additional educational options have emerged. Frist, the CRCDS School for Christian Leadership is now being offered online. We would like to rec3eive approval to present that option for those who may have schedule conflict with the on-site location. Secondly, Union Presbyterian Seminary is now offering an online program tailored as a CRE educational opportunity. This *Pathways to Learning and Leadership*, while somewhat less comprehensive, is much less expensive, time consuming, and is flexible in timing. As such, it may be a more practical option, yet provide adequate educational preparation for some persons desiring to work toward CRE commissioning. The committee on Ministry and General Council support the Committee on Preparation for Ministry's request for presbytery approval of this amendment to the CRE Formation Program.

OLD BUSINESS

A. Building listing and interest

Session voted to reduce the asking price to \$192,000, on the advice of the realtor. One church has visited three times; it is interested, but it is notoriously slow.

B. Funds

Funds are being consolidated into the checking account; the Merrill Lynch funds have been liquidated; Memorial Fund balance has been transferred; the Helen Sprecher Student Loan Fund was transferred to First Presbyterian Church in Elmira with a request that they oversee the fund.

C. Donations

Donations of \$1,500 to both Interfaith Hospitality Center (mission at the prison) and Compeer (works with disadvantaged youth) in memory of Joan Geldmecher; \$500 was sent to ARC (who has been cleaning the building); one-year severance check sent musician Jose Gomez for his faithful commitment to the music ministry of Westminster; paid the balance of per capita and mission pledge to Presbytery for 2018; pots and pans donated to the Hammond Presbyterian Church in memory of Cathy Stevenson; wrapping supplies donated to Elmira Psychiatric Center; Styrofoam cups/containers were given to EOP; a special gift (pocket watch) was given to Matthew (who has done many things in the church); Session voted to donate the pew Bibles to the Burdett Presbyterian Church

D. Keys

Keys are being collected; nearly all are in possession of church members; Board of Elections has keys

E. Deed

Rev. Winters found the deed and the abstract; she also found incorporation papers. Local lawyers will take care of getting the clear title, when it comes time for closing.

F. Workers' Compensation Liability Policy

This has been cancelled, since Jose, the musician, was the only employee who needed to have this.

G. Odds and ends

A prayer group (Westminster and Central Christian) is visiting a number of churches this summer; people are meeting every Thursday 10 to noon to work on items that either need to be packed or prepared for sale; no official date has been set for a sale of items, but it probably will be the end of August.

 - a. Letter to "active" members who are functionally "inactive"

The intent is to urge them to either find another church home or ask to be removed from the rolls. b. Shut-ins

- We hope to link shut-ins that are far away with churches that are near to them; through Jeff and Betsey, we will ask Deacons at their churches to coordinate with the Westminster Caring Friends (the group that functions like a Board of Deacons) to make contact with shut-ins who are nearby (five or six of them; four households).

- B. Financial matters

Session decided to keep telephone service for now, but no Internet; Betsey will suggest one or two people who are qualified to conduct the audit

- C. Session records
