The Commission has received a purchase offer for the Westminster building from Monumental Baptist Church. She described the excitement of the members of Monumental Baptist, who participated in a walk-through of the building.

The remaining financial resources of the church have been consolidated into one account: @ \$43,000.

Requested membership actions (two removals from the roll and one request for transfer) have been completed. The contents of the building have been removed or spoken for, with the exception of 100 blue *Presbyterian Hymnals*.

One remaining item is a beautiful rendition of the banner of the former United Presbyterian Church in the United States of America (UPCUSA). Through a Facebook page, "Happy to be a Presbyterian," a church requested the banner as a means of honoring their past connection to the former denomination.

More than 100 people attended the church's dissolution service.

The Commission has been working with a local attorney regarding the sale of the building. Out of that work the Commission proposed two motions

#### **CAMP WHITMAN - CAPITAL CAMPAIGN**

Lea Kone, Camp Whitman Director, thanked the presbytery for acting to make the position of Director a full-time position. She began in that capacity on January 1, 2019.

Lea reported concerning the Camp Whitman Capital Campaign: Seeds of Hope.

The Run River Consultants work with the Camp Whitman Committee was excellent and lifted up two major categories of bringing the camp to strength:

- 1. Mission development
- 2. Facility Planning

The initial, modest \$200,000 campaign more than doubled following the giving of a \$250,000 matching gift for Camp Whitman mission and facility development.

The current status of the campaign is:

\$171,000 raised to date, from:

Churches: Canandaigua, Geneva, Waterloo, Christ the King, Laurelton (Rochester)

Foundations Communities

Individuals: Thanks to Jeff Richards and Phil Opdyke for generous contributions

\$79,000 – the amount remaining, to be raised over the next year.

Today marks the beginning of the *Seeds of Hope – Camp Whitman* campaign. Brochures are available in the registration area. All churches, leaders, and members are encouraged to be aware of and to support the events and activities which will help us to attain the \$79,000 remaining in the campaign challenge.

Lea presented some "before and after" slides of the work already completed: new steel roofs and painting of several cabins; the renovation and upgrading of staff cabins so that they may be available for adult groups from our churches (session retreats, adult programming, etc.), and the upgrading of the floor in the Lodge.

Linda Werts reported that our presbytery will be hosting the triennial 2019 *Mission Experience – Finger Lakes Region,* bringing guests from all over our country, and some international visitors. The theme for the experience will be "Standing on the Shoulders of Empowered Women."

In addition to hands-on opportunities, the participants will visit several historic sites in our area, including the National Women's Rights Museum (Seneca Falls), the Harriet Tubman home (Auburn), and others.

The Presbyterian Women needs—now—team members for planning the event.

#### 2019 YOUTH TRIENNIUM REGISTRAR

The Rev. Deb Lind, who has stepped forward to be the Registrar for the 2019 Youth Triennium at Purdue University, encouraged presbyters to encourage the youth of their churches to enroll. The deadline is **the end of February.**

# Internal Business: "The Presbytery of Geneva lives. . . ." Part 2 PREPARING FOR THE FUTURE

#### (Presbytery Transitional Leader)

Elder Linda Badger Becker reported to the presbytery. She briefly reviewed the steps of the Transition Process to date, and the results of each step. We are now at the current stage of restructuring and implementing the Purpose, Vision, and Strategy for the presbytery's work. She observed that the presbytery is in a very good place to seek a Presbytery Leader.

She observed, "There are lots of changes, and thus a good bit of nervousness and anxiety, but the work that the presbytery's leaders and the presbytery has done is wonderful grounding for moving forward. She noted, "If change isn't awkward, it isn't change. She led the presbytery in a quick exercise in experiencing and reflecting on one aspect of change, noting that one aspect of change is loss, and we need to acknowledge that. The fruit of the hard work of the past year-and-a-half is the ability for the change and loss to be grounded in God's love and grace, and God's purpose for this presbytery. She reminded the presbytery of the promise in Jeremiah 30:29.

- Acknowledge with gratitude the blessings of a dissolved congregation in supporting the Purpose and the Vision of the Presbytery of Geneva.

#### **Background and Rationale**

After lengthy discussion on how Presbytery meetings can best serve our Purpose and Vision, Council VOTED to:

- 1. **Continue** our current pattern of five meetings a year for March 2019 through January 2020. This is because of all the changes coming with the new structure and staff in 2019.
- 2. **Approve** the following schedule of meeting days for the coming year, in order to meet the needs of pastors, people with family commitments, and people with secular weekday jobs: for this coming year we will:
  - a. Hold only one Saturday meeting, namely the January 2020 meeting, which will be a morning-only meeting. (The January 2019 meeting was already set.)
  - b. Hold two day-time Tuesday meetings and two evening Tuesday meetings.

Additional ideas for the Camp Whitman meeting included: optional wagon tours of the grounds that afternoon before the meeting; a hot dog roast for dinner; worship around the camp fire; and the opportunity following the meeting for people to stay the night at their own expense.

Additional ideas for the January meeting: the annual necrology and an educational event, possibly Presbyterian Disaster Assistance training.

### The General Council also VOTED to:

- **Survey our congregations** about their seating capacities, meal capacities, and other facilities (whether in their own building or borrowable nearby) to aid in scheduling Presbytery gatherings, both regular meetings and special events.
- Inform host churches that it may be necessary to adjust one or more of our planned times if our new staff have existing schedule conflicts.
- Attempt to have the following year's meeting pattern, dates and locations decided by November 2019.

# **ATTACHMENT A**

Child, Youth, and Vulnerable Adults Protection Policy, Presbytery of Geneva

#### I. Statement of Purpose

The Presbytery of Geneva seeks to provide a safe and secure environment in which children, youth, and vulnerable adults can spiritually develop and are protected from inappropriate treatment of any kind. Our intent is: to protect children, youth, and vulnerable adults during all Presbytery events or activities; to educate staff and volunteers concerning pertinent issues; and to provide accountability to protect staff, volunteers and the Presbytery.

#### II. DEFINITIONS

The following is a comprehensive list of definitions of terms and their intended use in this policy:

Child, children, youth: Any person under the age of 18.

**Child/ Youth Worker:** Any person, volunteer or paid staff or contractor, who participates at any level at Presbytery entity sponsored events or activities involving children and/ or youth.

**Child /Youth Abuse:** Any act or failure to act that results in the physical, sexual, psychological, or emotional mistreatment, neglect, or exploitation of children, youth, or vulnerable adults.

<u>Physical abuse</u> – any physical injury to a child that is not accidental. This can include hitting, beating, shaking, burns, or biting.

<u>Emotional abuse</u> – emotional injury takes place when a child is not nurtured or provided with love and security. This can include threatening, yelling, constant criticism, belittling, bullying or constant teasing.

<u>Sexual abuse</u> – any sexual activity between an adult and child or between a child and another child at least four years older than the victim. This can include fondling, exhibitionism, intercourse, or pornography.

<u>Neglect</u> – depriving a child of his/her essential needs. This can include lack of provision of food, water, shelter or medical care.

Misuse of technology: The use of technology that results in the abusing of a child or youth.

**Vulnerable Adult:** Any person eighteen-years-old or older who may be receiving community care services because of learning, physical or mental disability, age, or illness, or who may be unable to take care of him or herself, or unable to protect him or herself against significant harm or exploitation; who is without the developmental or cognitive capacity to consent.

#### III. Mandatory Event Rules For Working With Children, Youth, and Vulnerable Adults

The following rules apply to all individuals who work with children or youth at any Presbytery event or activity.

#### A. Two Adult Rule

At any Presbytery event or activity with children, youth, or vulnerable adults there will be no less than two un-related approved adults present. For overnight activities, there should be at least one approved adult of each gender where appropriate.

### B. Ratios:

The adult to child ratio for all child-related events/activities is 2:10. The adult to youth ratio for all youth-related events/activities is 2:17.

#### C. <u>Designated Person</u>

The Presbytery will ensure that there is an approved Designated Person responsible for safeguarding vulnerable adults ensuring their safety and well-being. This person must understand his/her responsibility to refer incidents of abuse to the relevant authorities.

# D. Open Door Policy

All rooms set aside for children and youth must have a door with a clear window in it through which the room is visible. Otherwise, the door to the room shall remain open. Adults assisting small children or infants in bathrooms shall prop open the door.

### E. Age of Volunteers

All child and youth workers must be at least 18 years of age and must be a minimum of four years older than the age group they lead or supervise. There may be times when it is permissible to use the services of youth, who are themselves under the age of 18, to assist in caring for younger children during Presbytery events or activities. In this case, the person must be at least 13 years old, must be under the supervision of an adult, and must never be left alone with children.

#### F. <u>Discipline Policy</u>

Under no circumstances is corporal punishment justified. There should be no spanking, grabbing, hitting, or other physical discipline of children. Volunteers should consult with the designated event leader if

assistance is needed with disciplinary issues.

#### G. <u>Transportation</u>:

All adult drivers at child/youth events must have proper licensure and insurance on file with the organizing council. All vehicles used must have seat belts for the driver and each passenger. All drivers transporting children and/or youth must be over the age of twenty-five and must be informed that if their vehicle is used, their insurance would be primary if an accident occurs.

#### H. Code of Conduct

- a. All volunteers and employees at any Presbytery child or youth events and activities must also abide by a code of conduct that emphasizes the following prohibited behaviors, including but not restricted to:
- b. Display of sexual affection toward a child.
- c. Use of profanity or off-color jokes.
- d. Discussion of sexual encounters
- e. Dating or becoming "romantically" involved with children, youth, or vulnerable adults.
- f. Using or being under the influence of alcohol or illegal drugs in the presence of children.
- g. Possessing sexually oriented materials—including printed or online pornography—on church property or property being utilized for a church event.
- h. Having secrets with youth/children.
- i. Staring at or commenting on children's bodies.
- j. Engaging in inappropriate or unapproved electronic communication with children.
- k. Working one-on-one with children in a private setting.

#### IV. Screening of Child/Youth Workers

All persons desiring to work with children or youth at Presbytery events or activities will be screened and must be approved for service. The screening includes the following:

A. Reference Checks

Before working with children or youth, at least three of the applicant's references will be checked.

Acceptable references may be received from the pastor or clerk of session from the person's church affiliation, employment references, or references from other volunteer agencies.

B. Criminal Background Checks

All applicant child/ youth workers must complete and sign a background check consent and authorization form or give evidence of a background check within the three years. A criminal background check will be conducted for any and all volunteers seeking to work with children or youth at Presbytery events or activities. Any convictions for an offense involving children or youth will disqualify an individual for working with children and youth. Conviction for other offenses may also disqualify an applicant following consultation with the Presbytery's insurance company. Failure to disclose a felony conviction on the application will also disqualify the applicant.

# V. Responding to Allegations of Child, Youth, or Vulnerable Adult Abuse

- A. Allegations of any kind of abuse will be responded to using the same processes as outlined in the Presbytery's sexual misconduct policy, whether or not those allegations are of a sexual nature.
- B. Any child/youth worker who becomes aware of or suspects any incidents of abuse or neglect of children or youth under care at a Presbytery event or activity, should report it immediately to the Event Coordinator, Presbytery Leader or Stated Clerk for further action, including reporting to authorities following applicable state laws.
- C. If an incident of abuse or neglect is alleged to have occurred at a Presbytery event or activity, the parent or guardian of the child, youth, or vulnerable adult will be notified as soon as possible.
- D. The Presbytery's insurance company will be notified, and an incident report will be filed. Any documents received related to the incident or allegations will be forwarded immediately to the insurance company.

# **Training**

The Presbytery will provide periodic Boundary Awareness Training that will include the Child, Youth, and Vulnerable Adult Protection Policy to ensure that all members of the Presbytery staff and all volunteers serving youth and children are fully informed concerning the Policy guidelines.
