Following a challenge to the findings of the PJC moderator and PJC Clerk (in accordance with D-6.0306a), Remedial Case R-2019-1 was reviewed by the full Permanent Judicial Commission at a hearing on June 21, 2019. The finding of the Moderator and Clerk that the complaint does not state a claim upon which relief can be granted was overturned; therefore, Remedial Case R-2019-1 was approved to go to trial.
  - Prior to the scheduled trial, the Complainant and Respondent in Remedial Case R-2019-1
    met and came to a mutual agreement; the Complainant formally withdrew all charges and
    the case was dismissed.
  - The Permanent Judicial Commission of the Presbytery of Geneva met on June 21, 2019, and approved the signed consent agreement and order of Disciplinary Case D-2018-01, the Presbytery of Geneva vs the Rev. John McDonald. This consent agreement and order stands as the final decision of the PJC in this case.

#### CONSENT AGREEMENT AND ORDER

#### Disciplinary Case D-2018-01

The Presbytery of Geneva v. Rev. John McDonald

The Presbytery of Geneva, through its Prosecuting Committee in this matter, and the accused, the Rev. John McDonald, do hereby consent and agree to the entry of this ORDER by the Permanent Judicial Commission of the Presbytery of Geneva:

Rev. John McDonald hereby pleads guilty to the following charges:

#### Charge 1

In early 2016, while serving as the Associate Pastor of the First Presbyterian Church of Ithaca, NY, Rev. John McDonald, did commit the offense of "sexual abuse" - defined in the PCUSA Constitution (D10.0401c(2)) to include any "misuse of ordered ministry or position" of a sexual nature--and violated his ordination vows (W4.0404f,g), in that he was recklessly or negligently responsible for the exposure of his sexually explicit photos and texts to a young adult woman in the congregation who was disturbed upon viewing them. In particular, McDonald shared sexually explicit messages and photos with an adult gay male on an adult gay dating app who then shared the photos with the young woman in the congregation, who, it turned out, was a friend. Even though Rev. McDonald may not have known that the messages would be shared with the young woman, nonetheless he was negligent or reckless when sharing such sexually explicit messages with someone in a position to re-share them with a church member. The result of McDonald's conduct was that the young woman who had recently and enthusiastically joined the church, suddenly stopped participating in the church community. Several months later, in June, Elder Christina Mead ran into her casually in the community and asked her about her absence. She confirmed to Elder Mead that a friend of hers had gone on a date with McDonald and that the friend had felt harassed with sexually explicit communications from McDonald to the point that he blocked further messages from McDonald on the gay dating app. When riend showed her the communications, she was distressed to the point that she felt that she couldn't attend church anymore.

## Charge 2

In February 2018, while serving as the Associate Pastor of the First Presbyterian Church of Ithaca, NY, Rev. John McDonald, did commit the offense of "sexual abuse" — defined to include the 'misuse of ordered ministry or position" of a sexual nature (D10.0401c(2)) — and violated his ordination vows when he invited 20-year old an undergraduate student who had been singing in the choir of said church to his home at night. McDonald had been

## Charge 3

In or about February of 2018, while serving as the Associate Pastor of the First Presbyterian Church of Ithaca, NY, Rev. John McDonald, did commit the offense of sexual abuse— defined to include 'misuse of ordered ministry or position" of a sexual nature (D-10.0401c(2)) — and violated his ordination vows (W4.0404f,g), in regards to the sharing of sexually explicit and inappropriate photos and messages with student who had been attending said church, through electronic and/or other communications, including text messages. According to McDonald, McDonald previously had shared sexually explicit photos with an adult gay male who McDonald formerly had dated. The gay male friend subsequently shared McDonald's photos and messages with whom he had met through a gay dating app. was disturbed, offended, and harassed by the sharing. Even though McDonald may not have known that his photos would be shown to nonetheless was recklessly or negligently responsible for having been exposed to sexually explicit material originating with McDonald. believed and continues to believe that the person who contacted him and shared McDonald's sexually explicit photos and messages and encouraged to date McDonald was none other than McDonald himself pretending to be someone else through the use of an anonymous online identity. This offense was committed after McDonald had been previously warned by Rev. Kirianne Weaver-Riehl (Head of Staff) and Rev. Cynthia Weaver to cease and desist from similar conduct and failed to heed said warnings.

#### ORDER

WHEREAS, you, Rev. John McDonald, have pleaded guilty to the offenses of "sexual abuse" — defined in the PCUSA Constitution (D10.0401c(2)) to include any "misuse of ordered ministry or position" of a sexual nature—and violated your ordination vows (W4.0404f,g), and by such offenses you have acted contrary to the Scriptures and the Constitution of the Presbyterian Church (U.S.A.));

NOW, THEREFORE, the Presbytery of Geneva, in the name and by the authority of the Presbyterian Church (U.S.A.), does now declare you TEMPORARILY EXCLUDED FROM THE EXERCISE OF ORDERED MINISTRY until such time as you have satisfactorily completed a rehabilitation program supervised by the Committee on Ministry of the Presbytery of Geneva ("COM"), as described below:

 COM shall have sole, full, and complete authority to supervise Rev. McDonald's rehabilitation, subject only to this Permanent Judicial Commission's authority over this Consent Agreement and Order. The following terms shall govern Rev. McDonald's rehabilitation:

- a. Rev. McDonald will attend and satisfactorily complete the intensive Clergy Program at the Davidson Center for Professions, if he has not already done so. COM has previously agreed that payment for this shall be made as follows: 1/3 from the Presbytery of Geneva, 1/3 from a Counseling Fund given by First Presbyterian Church of Ithaca, and 1/3 from Rev. McDonald (Letter from Rev. Adrian J. Tierson, Co-chair to Rev. John McDonald, dated Apr. 4, 2018).
- b. Rev. McDonald shall also attend on-going therapy sessions with a licensed professional counselor no less than twice-a-month until such time as his temporary exclusion is lifted. The subject of these therapy sessions shall include, but not be limited to, developing an understanding of why he behaved as he did toward the persons injured by his behavior and how to prevent any such incidences from occurring again though modification of his behavior. Rev. McDonald is responsible for the costs of this therapy.
- c. Rev. McDonald shall execute any and all necessary releases for Davidson Center counseling staff and any and all other professional counselors to discuss his condition and progress with members of COM and to release copies of any and all written reports for their review and shall cooperate fully with COM to ensure this occurs. Rev. McDonald shall facilitate the sharing of these reports with COM. This provision shall remain in effect for the full period of his temporary exclusion. The COM shall promptly inform Rev. McDonald whether the reports previously received demonstrate satisfactory completion of this condition, and, if not, specify what is lacking.
- d. Within 45 days of any application for restoration by Rev. McDonald under D-12.0104h, i (paragraphs 6-7 of this ORDER), COM shall prepare and deliver a written recommendation to the Presbytery of Geneva, through its Stated Clerk, regarding whether it believes that his application should be granted based on his compliance with the terms of this ORDER and reports received from his therapists. Rev. McDonald shall ensure that any and all such reports are submitted to the COM and are up-to-date as of the date of his application.
- e. After receiving Rev. McDonald's application for restoration and the recommendation of COM, the Presbytery of Geneva shall take up the application at its next stated meeting wherein time is reasonably available on the docket to do so.
- 2. Rev. McDonald shall acknowledge his guilt in separate written letters sent to the last known addresses of Mr. Mr. Mr. Sincere repentance of his actions as described in this OKDEK. Copies of these

letters shall be submitted by Rev. McDonald to COM before being sent, and COM will promptly inform Rev. McDonald whether the letters satisfy this condition. Compliance with this paragraph shall be considered a required term of Rev. McDonald's supervised rehabilitation and a condition precedent to the lifting of the censure of temporary exclusion from the practice of ordered ministry (D-12.0104c).

- During the period of temporary exclusion from ordered ministry, Rev. McDonald shall refrain from the exercise of any function of ordered ministry as a Teaching Elder or Minister of Word and Sacrament of the Presbyterian Church (USA) or any other religious body (D-12.0104d).
- During the period of temporary exclusion from the exercise of ordered ministry, Rev. McDonald shall refrain from participating and voting in meetings and from holding or exercising any office in the Presbyterian Church (USA) or any of its congregations and councils (D-12.0104e).
- The Stated Clerk of the Presbytery of Geneva shall immediately send the information of the action taken in this ORDER to the Stated Clerk of the General Assembly as required by D-12.0104g.
- 6. Rev. McDonald shall apply in writing to the Presbytery of Geneva, through the stated clerk, for restoration upon the completion of the supervised rehabilitation pronounced. The Presbytery of Geneva shall approve the restoration when it is fully satisfied that the supervised rehabilitation pronounced has been satisfactorily completed (D-12.0104h).
- 7. Rev. McDonald may apply in writing to the Presbytery of Geneva, through the stated clerk, to be restored prior to the completion of the supervised rehabilitation fixed in the censure. The Presbytery of Geneva may approve such a restoration when it is fully satisfied that the action is justified (D-12.0104i).
- 8. If Rev. McDonald makes an application for restoration and it is denied by the Presbytery of Geneva, the period of his temporary exclusion from the exercise of ordained ministry shall continue until such time as Rev. McDonald makes an application that is successfully granted by the Presbytery of Geneva.
- The Prosecuting Committee and Rev. McDonald hereby waive any right of appeal from this CONSENT AGREEMENT AND ORDER.

## REFLECTION ON THE WORD & LORD'S SUPPER

## PRESBYTERY WORSHIP SERVICE

The presbytery engaged in a summer camp-style service of worship, led by the Rev. #### **GOOD NEWS FROM THE CHURCHES**

The moderator called for brief expression of good news in the lives of churches in the Presbytery of Geneva. Good news included:

 A work team of 8 members from the First Presbyterian Church of Ithaca will be traveling to New Bern, NC, on October 13 for a week of rebuilding with Presbyterian Disaster Assistance.

#### REPORT OF THE STATED CLERK

Stated Clerk Rev. Amy Loving Austin read the report of Remedial Case R-2019-1 and the decision of Disciplinary Case D-2018-01 (as required by the *Book of Order* D-7.0701 and D-11.0701, and as included in the Consent Agenda), noting that the full decision would be entered upon the minutes of this meeting.

- There was a question about the appropriateness of reading the D-2018-01 decision and including it in the
  meeting documents. The Stated Clerk explained that this is required by the Book of Order and was
  confirmed by the General Assembly Office.
- There was a request to password-protect the full decision of D-2018-01 to limit outside access to the document. It is required that the full decision be entered into the minutes of this meeting (Appendix A). The Clerk stated that she would consult with the GA Office and General Council to determine the best way to both honor the requirements of the *Book of Order* and desire to protect the identities of victims in this case.

## **PRESBYTERIAN TRIENNIUM**

Rev. Deborah Lind-Schmitz (Geneva) as well as Triennium attendees Emily McFarlane (Palmyra, Western) and Jody Pruitt (Palmyra, Western) presented the report of the 2019 Presbyterian Youth Triennium:

- Presbyterian Youth Triennium is a gathering for high school age youth from the Presbyterian Church (USA) and the Cumberland Presbyterian Church that occurs every three years. The 2019 event was held July 16-20, 2019 at Purdue University. The theme for the 2019 event was "Here's My Heart", taken from the hymn Come Thou Fount of Every Blessing.
- There was quite a bit of walking involved, but the real highlight was all of the relationships that developed and grew during their time together - with their group of youth and leaders, as well as with youth from all over the country and globe.
- Youth enjoyed passing the peace in a different language at every worship service. The energy and exuberance at the worship services, where youth connected to God and scripture, was inspirational.
- Several of the youth who attended have expressed interest in returning as PYT leaders in future years.

#### **PRESBYTERIAN WOMEN**

Elders Linda Werts (Canandaigua), Virginia Champlin (Geneva), and Lois Carter (Hector) presented the report from Presbyterian Women:

• (From <a href="www.presbyterianwomen.org">www.presbyterianwomen.org</a>) "The USA Mission Experience takes a group of Presbyterian Women to a part of the United States to connect concerns raised by past Global Exchanges with similar issues in

the United States. With local mission projects as partners, the participants combine education with hands-on ministry during the weeklong trip. Participants encounter challenges to God's promise of a beloved community and witness the faithful responses of Christians living and working in difficult situations." "A group of Presbyterian women will travel to the Finger Lakes Region of New York, July 12–22, 2019, for PW's fifth USA Mission Experience. They will explore the rich history that Presbyterian women have in the women's and civil rights movements. These women will also have the opportunity to learn more about themselves and about the people of the Finger Lakes Region, including migrant workers and Native Americans."

"Highlights of the journey will include a day in Seneca Falls at the Women's Convention at the National Women's Hall of Fame; a visit to the Susan B. Anthony home; and a visit to the Harriet Tubman House. The USA Mission Experience equips women with an understanding of the region's history and culture, the existing ministry of the church there and the challenges faced by women and children living in the area. Participants serve as ambassadors for the region during two years of itineration following the experience."

The PW representatives shared a slide show which highlighted the recent USAME here in the Finger Lakes
region, which our Presbytery helped to plan and organize. Virginia Champlin was especially recognized for
her hard work for making this event possible - and helping to make it such a wonderful success. The slide

## **CAMP WHITMAN**

Elder Jeff Richards (Elmira, North), Elder Lea Kone (Camp Whitman Director), and Rev. Leah Ntuala (Seneca Falls) presented the report from Camp Whitman:

- The committee stayed at Camp Whitman for a committee retreat September 20-21, using the time to work
  on a mission statement. The first draft of the mission statement: Camp Whitman on Seneca Lake lives for
  those who are longing for belonging, seeking connection with community and creation, respite from chaos
  and competition, and an opportunity to encounter both the Holy and themselves.
- A total of 384 people were served by Camp Whitman in 2019:
  - o 258 Residential Camp Whitman Campers (97 Pine Campers, 161 Traditional Campers)
  - 51 Youth Group Kids, 30 Youth Group Campers
  - o 36 Day Group Kids, 9 Day Group Chaperones
  - Day Group: Cameron Community Ministries
  - Youth Groups: Camp Quin, First Pres Ithaca, Lake Street Pres Elmira, Wilson Commencement Park
  - Highlights included: 3 campers from China and 5 campers from RAIHN (partial scholarship funding from Pittsford Presbyterian Church)
  - The camp continues to benefit from a partnership with the DRIVE program of Keuka College and the Yates County ARC.
- Campers benefitted from \$3,900 total in scholarship funding
  - 5 Full Scholarships for RAIHN campers
  - 11 Partial Scholarships (Average \$100)
- Thank you to Chaplains: Bruce Incze, Kirianne Riehl and James Renfrew.
- Thank you to all of the "small but mighty" Fall Volunteer Days attendees!
- The Fall Festival went well, with 60 people attending (including volunteers and staff).
- \$233,300 has been raised for the Capital Campaign to date, with \$16,700 remaining.

- The committee has approved 2 Small Church Program Grants: one to Shortsville Presbyterian Church and another to West Fayette Presbyterian Church. There is still more grant money available, and churches are urged to apply.
- There will be a Spiritual Gifts Workshop for all churches on Saturday, October 19 from 9-noon, at the Penn Yan First Presbyterian Church.

#### **COMMITTEE ON LEADER CARE**

Rev. Bruce Incze (Arkport) presented the report of the Committee on Leader Care:

- The Presbytery of Geneva maintains an Emergency Assistance Fund to aid pastoral leaders, including CREs. When an emergency arises in the life of one of our pastors and financial assistance is needed, a request for aid can be made to the Presbytery Leader. This request will be treated in confidence. After Personal Identifying Information (PII) is removed, the Presbytery Leader will consult with the Chairperson of the Leader Care Committee to consider the request. Additionally, if the Presbytery Leader determines that the situation may be eligible for matching funds from the Board of Pensions, the Presbytery Leader will contact the Board.
- There is currently \$536.28 in the fund. Please consider contributing to the health of this fund so that as a presbytery we are prepared to appropriately and discretely address emergency needs of our pastors in a timely manner. The worship offering from our November meeting of the presbytery has been designated to go into this fund.
- The LCC welcomes your feedback about what else they could be doing in the presbytery. Also, if you know
  of a need, please let the committee know.

Addendum to the Covenant Agreement for Interim Pastor signed on July 17, 2018 here attached, between the Geneva Presbytery and Reverend Dr. W. David Ashby and in Concurrence with the Official Board of the United Church of Canandaigua.

Paragraph 6 of the Agreement shall be removed in its entirety and replaced with:

6. This agreement is for a period of 12 months commencing on August 1, 2018. The agreement will terminate on July 31, 2019 with no further compensation or benefits. The Interim Pastor shall be on

Paid Leave which will include all accrued Study Leave time and Vacation from May 6, 2019 to July 31, 2019. To allow the church to develop independence during the time of the Paid Leave the Interim Pastor will abide by the ethical standards normally agreed to when a Pastor is no longer the active Pastor. Any required communications shall be made through the Official Board representative.

Paragraph 8 of the Agreement to be removed in its entirety. Paragraph 9 of the Agreement to be removed in its entirety and replaced

- 9. The Interim Pastor will receive no compensation or severance after July 31, 2019 and agrees to seek full time employment during his Paid Leave from May 6, 2019 to July 31, 2019. The Interim Pastor's compensation and benefits will terminate upon full-time employment in another position.
- Approve the one-year covenant between Phelps United and the Rev. Ellen Donnan, as transitional pastor,

to begin July 1, 2019. Rev. Donnan would be employed on a Three-Quarter-Time basis and compensated as follows:
