The Presbytery agreed to grant voice to corresponding members and guests for the purpose of giving reports.

## ACKNOWLEDGEMENT OF THE FIRST STEWARDS OF THE LAND

Rev. Leah Ntuala (Seneca Falls, First) offered the following statement:

Before I begin today, I want to acknowledge and recognize, the Iroquois Nation, on whose traditional territory we are gathering. We acknowledge them as the past, present and future caretakers of this land. Every community owes its existence and vitality to generations from around the world who contributed their hopes, dreams, and energy to making the history that led to this moment. Some were brought here against their will, some were drawn to leave their distant homes in hope of a better life, and some have lived on this land for more generations than can be counted. Truth and acknowledgment are critical to building mutual respect and connection across all barriers of heritage and difference. We begin this effort to acknowledge what has been buried by honoring the truth. We are standing on the ancestral lands of the Iroquois Nation People . The name Cayuga means "People of the Great Swamp." They belong to the Iroquoian language family, and were one of the original Five Nations of the League of the Iroquois. Our present Seneca County was the home of the Cayuga and Seneca Indians, two of the six tribes making up this Iroquois Confederacy. We pay respects to their elders past and present. Please take a moment to consider the many legacies of violence, displacement, migration, and settlement that bring us together here today. And please join us in uncovering such truths at any and all public events. Acknowledgment by itself is a small gesture. It becomes meaningful when coupled with authentic relationship and informed action. But this beginning can be an opening to greater public consciousness of Native sovereignty and cultural rights, a step

toward equitable relationship and reconciliation. Between 1776 and 1887, the United States seized over 1.5 billion acres from America's indigenous people by treaty and executive order. Acknowledgment should be approached not as a set of obligatory words to rush through. These words should be offered with respect, grounded in authentic reflection, presence, and awareness. As you step up to offer acknowledgment, breathe in awareness of both the present and of the histories that connect you with the people you are naming. Consider your own place in the story of colonization and of undoing its legacy. At your next gathering, try acknowledgment out, see how it feels, observe how or if it shifts the room. Over time, through practice, you'll learn more about what it means and what it opens up for you and others. Together, we can spark a movement to make acknowledgment of traditional lands a regular practice at public and private events. Acknowledgment is a simple, powerful way of showing respect and a step toward correcting the stories and practices that erase Indigenous people's history and culture and toward inviting and honoring the truth.

"The power that Jesus Christ has vested in his Church, a power manifested in the exercise of church discipline, is one for building up the body of Christ, not for destroying it, for redeeming, not for punishing. It should be exercised as a dispensation of mercy and not of wrath so that the great ends of the Church may be achieved, that all children of God may be presented faultless in the day of Christ (*Book of Order*, D-1.0102)."

RE Ken Allen presented the motion, from the COM, and the Presbytery VOTED to:

• Sustain the examination of Michelle Serra.

• **Enroll** Michelle Serra, member of The United Church of Hornell and lay pastor of First Presbyterian Church of Canisteo, as an inquirer (G-2.0603). The Moderator led the Presbytery in prayer.

Rev. Leah Ntuala (Seneca Falls, First) was invited to share a few words, recognizing RE Stephen Beals, who will be ending his service at West Fayette this summer:

"Stephen is a Ruling Elder of the 1 st Presbyterian Church in Seneca Falls. He is the CRE for West Fayette, the little church with the big heart. When I first met Stephen he was in Seminary, what he discovered was a music ministry. He has both a joy and a gift for writing and playing music. He used this gift to grow a very special Advent Carol Sing in his church, overflowing the pews- standing room only. He leads the people he serves by working alongside of them. He does everything he can at the strawberry festival, the bbq and chicken dinners. He leads a service and attends the final moments of the congregation I serve, always staying for coffee hour. He has worked and served the Presbytery and various committees. His passion, gifts and joy will be missed. He will continue to serve God in all he does."

## **BUSINESS RELATED TO MISSION**

## **VITAL CONGREGATIONS INITIATIVE (VCI)**

Rev. Cara Milne (Watkins Glen, First) and Rev. Stanley Bhasker (Bath, First) offered an update on the Vital Congregations Initiative (VCI).

- Due to COVID-19 travel restrictions, Vital Congregational Initiative Austin trainings are virtual now.
   Please mark your calendar for August 18-20, 2020 Virtual Vital Congregations Gathering (featuring Bill Brown and Tod Bolsinger)
- Though the dates are pushed back, we are still part of the Second Wave, but on a fall track instead of winter one. So, we will be forming cohorts for June 2021 for a start date of September 1, 2021.
- VCI is offering weekly zoom meetings on Wednesdays for anyone and everyone in your churches.
   These gatherings resumed on Wednesday (May 27) with special Guest Diane Givens Moffett president of the Presbyterian Mission Agency. The next gathering is on Wednesday, June 3, 2020, with special guest J. Herbert Nelson, PCUSA Stated Clerk
- We are in conversation with Rev. Kathryn Threadgill, Coordinator for Vital Congregations and Rev. Carlton Johnson, Associate for Vital Congregations for a Zoom offering in our September Presbytery meeting.

#### **MISSION & WITNESS COMMITTEE**

Rev. Deb Grohman (Ontario Center, First) presented the report from the Mission & Witness Committee.

- The committee has designated part of their \$50,000 grant money to support our congregations by sending \$200 to each congregation.
- Emergency COVID-19 Grants are available; four have already been awarded, with more yet to be considered. There is no set deadline for this particular grant.
- The committee has extended the deadline for Session Mission Partnership Grants and Hunger Partnership Grants; the deadline is now August 3, 2020.

## **INTERNAL BUSINESS**

#### **GENERAL COUNCIL**

RE Dr. Rob Anderson (Penn Yan, First) provided an update on how COVID-19 is impacting the Finger Lakes region.

- As of the date of this meeting, there are approximately 1.7 million known cases in the USA, 360,000 of those are in New York State.
- While New York State is currently trending down (overall) in new cases, Ontario County has seen an
  increase.
- The state has provided some guidelines for In-person worship that can take place now: drive-in worship is allowed, with proper distancing and use of PPE; and small groups of 10 persons or less can meet as long as they are maintaining proper distancing and use appropriate PPE. All other in-person worship gatherings are not recommended until Phase 4 of the phased reopening of the region, at which time further safety guidelines will likely be shared.
- Singing and loud talking/vocal projection increases the transmission risk, so they are not recommended at this time.
- Dr. Anderson expressed cautious optimism regarding possible vaccines, noting that more testing is needed
  and is ongoing. He made note of the justice issues that are at play in this epidemic, pointing out the fact that
  wealthier nations (such as the USA) are buying up PPE and the rights to vaccines and other medicines,
  making it harder for non-wealthy nations to have what they need to be safe and protect their citizens.
- It is still very important that people continue to maintain physical distancing and other protective measures whenever they are together, including in worship settings. We are called to be courteous to others, respect all our neighbors, wear masks, and maintain proper distancing.

## **COMMITTEE ON OPERATIONS**

Rev. David Ashby (VM) presented the report from the Committee on Operations.

- We are gathering Presbytery Records and any Church Records to take to the Presbyterian Historical Society. A letter has been sent to congregations, inviting them to get church records to the Presbytery for the trip to the Historical Society by August 15, 2020.
- The Presbytery of Geneva and Camp Whitman have new logos:





#### REPORT OF THE STATED CLERK

Rev. Amy Loving Austin (Seneca #9 / Bellona) presented the report of the Stated Clerk.

- The Presbytery of Geneva's Minutes from 2019 were reviewed by the Synod of the Northeast. They were approved *with 3 exceptions*:
  - 1. The Presbytery failed to review the session minutes in 2019
  - 2. The Presbytery failed to report the recommissioning of CREs
  - 3. The Presbytery failed to report that COM has received and reviewed the annual reports of ministers performing work which is not under the jurisdiction of the presbytery or a higher governing body of the church, that COM has made recommendations to presbytery and that presbytery has acted on the recommendations (this refers to Validated and At-Large Minister Members).

# **REPORT OF THE PRESBYTERY LEADER**

RE Susan Orr (Genesee Valley Presbytery) presented the report of the Presbytery Leader.

Friends, I am Elder Susan Orr, your Presbytery Leader. Here we are having our second successful electronic meeting of Presbytery! We had all hoped we would be physically present with each other in Trumansburg but look at how well we have adapted to our present circumstances. Yeah for us!

Well, we are certainly flying this plane while building it! General Council has been studying the book, Canoeing the Mountains: Christian Leadership in Uncharted Territory by Tod Bolsinger. We began the study in early March back when we naively thought the "uncharted territory" was the rapidly changing church culture in the world, and we've really come to appreciate the Holy Spirit timing that has guided us to this particular book during COVID 19. This past month, the key leadership lesson was – No One is Going to Follow You Off the Map Unless They Trust You On the Map. The most critical attribute our Presbytery must have to thrive in uncharted territory is a healthy organizational culture. Organizational culture is the group of norms of behavior, and the underlying shared values that help keep those norms in place. NOTE: It is not the aspired values that shape the Presbytery's culture but the actual values that produce, and are expressed in, actual behaviors. A statement of values, or a mission statement, no matter how inspiring, does not make a healthy culture. People typically don't look at by-laws or policy manuals for clues to a congregation's culture, they observe the people. In other words, a church can say that it values hospitality, discipleship and transparency, but these become part of the DNA of the church only when they are so resiliently present that they happen automatically by default, because all aspects of the congregational life support and reinforce them. The actual behaviors of those in leadership and membership express and share the actual values of the congregational culture.

So let's review what we have said are our aspired values:

MISSION: The Presbytery of Geneva lives to support and equip congregations and leaders to

be Christ in the Finger Lakes and the world.

VISION: Radiating the light of Christ, the Presbytery of Geneva thrives as a community of

servants, lifting up every congregation and leader in ministering together.

When Presbytery leadership and committees are perceived as technically competent, they gain credibility in the eyes of the Presbytery. When they are perceived as relationally congruent, trust is established. When credibility and trust are mobilized to create a healthy Presbytery culture, then we are ready to embrace the thrilling and daunting task of entering uncharted territory. Creating a healthy culture *for us* requires identifying the gaps between these aspired values we just read and our actual behavior and practices, and then working with leadership, committees and our congregations to bring every aspect of the Presbytery into alignment with our core ideology. Because it's not the Council or the staff or our committees that live to support and equip congregations, it's all of us. *We're* the Presbytery of Geneva.

We've made great strides especially through this crisis – the weekly pastoral leader support calls sponsored by the Committee on Leader Care; the financial gift to each congregation and availability of COVID emergency grants by the Committee on Mission & Witness; the commitment to the Second Wave of the Vital Congregations Initiative by the Committee on Vitality, the continued guidance on re-opening our church buildings from Council....these are all examples of how our Presbytery is living to support and equip congregations and leaders to be Christ in the Finger Lakes and the world. My favorite example of living into our purpose is the brand new Out to Pastor Newsletter created by Rev. David Barnard, newly retired. David sensed a call to minister to his colleagues so he created this newsletter and sought partnership with Leader Care to distribute it to our honorably retired members, and it has received wonderful feedback. Now, this new thing wasn't created by leadership - but by one of you answering a call. David, thank you for radiating the light of Christ, for being an example to all how the Presbytery of Geneva can thrive together as a community of servants. For while the urgency of transformation is made evident by the reality of our present circumstances, the energy for transformation is inherent in our call and identity as followers of Jesus Christ. Presbytery of Geneva, we are not adapting to merely survive but to thrive. May it be so!
