**ADMINISTRATIVE COMMISSION REPORT  
ATLANTA PRESBYTERIAN CHURCH  
January 28, 2023**

The Administrative Commission for the Atlanta Presbyterian Church approved the following resolution on January 9, 2023:

Since the congregation of the Atlanta Presbyterian Church voted on September 28, 2021 to dissolve the church and to work with an Administrative Commission of the Presbytery of Geneva to sell the church building; and

The sale of the building of the Atlanta Presbytery to the Redefined Church closed on or about November 4, 2022;

The Atlanta Presbyterian Church Administrative Commission now agrees to:

Approve the dissolution of the congregation and corporation of the Atlanta Presbyterian Church as soon as practicable;

Recommend to the Presbytery of Geneva that it concur in the vote of the congregation that the congregation and corporation of the Atlanta Presbyterian Church be dissolved;

Seek and take any actions necessary or advisable to obtain any necessary approvals, including from the NYS Supreme Court after receiving approval from the Presbytery;

Pay all known expenses of the corporation; and

Distribute the remaining assets after closing costs, etc., of the Atlanta Presbyterian Church to local nonprofit entities and/or to the Presbytery of Geneva, with the guidance of the remaining congregation members of the congregation.

The Presbytery of Geneva VOTED to:

- **Concur** in the vote of the congregation that the congregation and corporation of the Atlanta Presbyterian Church be dissolved; **authorize the Administrative Commission** to seek and take any actions necessary or advisable to obtain any necessary approvals, including from the NYS Supreme Court; **authorize the Administrative Commission** to pay all known expenses of the corporation; and **authorize the Committee on Operations** to distribute the remaining assets after closing costs, etc., of the Atlanta Presbyterian Church to local nonprofit entities and/or to the Presbytery of Geneva, with the guidance of the remaining congregation members of the congregation.

Rev. Griffis led the Presbytery in prayer for the Atlanta congregation.
